## About *Protecting Canadian Children*

Alfredine Plourde, aka Linda is a mother, grandmother and author of the book "*Protecting Canadian Children.*" Alfredine founded a grassroots organization also called, "*Protecting Canadian Children.*" As a parent, Alfredine is very concerned about the health and well-being of children across our country who are taken into custody by the so-called "child protective services." Alfredine's book and her organization bring you the real truth behind today's "child protection services." It is vital for parents, grandparents and every citizen to understand what is going on in our country under the noses of unsuspecting Canadians. She discusses another inconvenient truth that no one else dares to talk about — the abuse and death of children across Canada

while in "protective" care. Alfredine has been widely recognized for her dedication to preserving and supporting vulnerable families in Canada. She was born in Bathurst, N.B. and spent her early years in the small village of St-Sauveur, N.B. Alfredine is a very proud French Acadian. She lives in Ontario.

"Alfredine spent 12 years and her retirement money to go around the country and meet with families, victims of the carnage of child protection agencies and the destruction of families. She has written a book and a magazine and met with countless people to bring attention to this problem. She never charges money to help and work with these families. People trust her because she is a mother and grandmother who is very concerned about the next generation. She is not part of the system and therefore people seek her help when their child dies or is taken by the CPS. She receives calls, emails and posts on her Facebook all the time. She has tried to walk away from this work but to no avail. When she receives a desperate call, it is beyond her to turn her back on the caller. She believes if we don't stand for children, we don't stand for much." – W. Robinson

Alfredine has first-hand experience. "In 2004 Catholic Children's Aid did nothing to stop the exploitation and neglect of my grandson, therefore under the law they are guilty accomplices. EVERYDAY, I count my blessings. My grandson was returned to us alive, hurt but alive. Therefore, when God granted me my grandson back, I immediately knew my life would be dedicated to help other children and my work did not end upon his return home. After hearing these words: "Children are dying" I had no choice but to tell all who will listen what the silenced victims would tell you if they could speak. We are witnessing the human capacity for cruelty in every sense of the word. We must speak. This magazine is not for entertainment, but is to bring awareness. It is worse than we'd like to think.

When I created *Protecting Canadian Children* it was never about me. Protecting Canadian Children does not belong to me, it belongs to all the children. Their voices need to be heard. They are the witnesses of truth. *Protecting Canadian Children* has never been about revenge or punishment but about change.

# The Least Understood Field of Civil Rights Today



Wendy Robinson won the award for the top student at St. Clair College, Windsor, ON from The International Business and Forum for International Trade Training Course. She went on to various projects and was the owner of a water quality, management company in Ottawa. For twelve years, Wendy has delivered workshops for students and adults on drug education, human rights and human rights abuses in the mental health field. Wendy has worked with Protecting Canadian Children for more than two years. Wendy recently completed the Paralegal Course, at Herzing College, Ottawa. Wendy has been a co-author of this magazine.

My work has brought me into contact and court with many families who have had their children taken illegally and aggressively by the various child protection services across Canada. Many of these children are drugged with psychiatric drugs and live lives of quiet desperation in foster homes, group homes, mental facilities and hotels where they are neglected, abused and many die each year. How does this happen in a country like Canada? Upon examination of the parents and families involved with many of these cases they “by law” did not warrant their children to be taken from them. I was astonished by what I learned working with these families of the callous, inhumane treatment of children and their families by so called professionals and administrative officials in our family court system. I became a paralegal to help these families get justice for their children and themselves.

After partnering with Linda Plourde, founder of Protecting Canadian Children, we have traveled across Canada to document the stories of these families to present a book of evidence to use with lawyers, judges, police, teachers, doctors, media and government officials. Our purpose is to create awareness and action to change this travesty of justice in our country. What we learned is that most people don’t care, don’t believe it or don’t want to hear about the vulnerable families who love their children and have them apprehended by out-of-control, social services personnel on a whim. Why would they do that you ask: to satisfy the inventory targets of greedy, money making, organizations and agencies masquerading as “child protection agencies” on behalf of the unsuspecting Canadian tax payers? This is not new in Canada but a repeat of so many other crimes against children in our history that the Canadian people have allowed.

## The Least Understood Field of Civil Rights Today (continued)

The Law has the power to guide us in establishing a fair and safe society for all citizens if we will submit ourselves to the laws we have, based on the Supremacy of God and the Rule of Law (Everyone is subject to laws, kings, paupers and everyone in between.)

*“The Canadian Charter of Rights and Freedoms, guarantees the rights and freedoms set out in the constitution but this charter has loop holes, s1 and s 33.” The courts will often defer to the government and take away your human rights if the government tells the court this is necessary.*

**Whereas “The Canadian Bill of Rights, 1960” is still in force and states that only an Act of Parliament can take away your human rights. That has never happened in Canada yet.**

Our human rights come from God, a higher source of law than our government. We are not given our human rights they are ours automatically, just for being born into humanity. Human Rights is a hot topic for teens and adults. When people know their human rights, they walk taller, have more confidence, know their boundaries and the government cannot control and suppress the populace easily. Let’s teach the next generation their human rights and civic duty. But what are your human rights? (Excerpted from the *Canadian Bill of Rights*, 1960.) It is recognized and declared in Canada there have existed and shall exist without discrimination..... the following human rights and fundamental freedoms, namely,

1. The right of the individual to life, liberty, security of the person and enjoyment of property, and the right not to be deprived thereof except by due process of the law;
2. The right to the individual to equality before the law and the protection of the law;
3. Freedom of religion; speech, assembly, association and freedom of the press
4. No arbitrary imprisonment, or cruel or unusual treatment
5. The right to know what you are accused of, the right to a lawyer
6. No unlawful detention, habeas corpus,
7. Presumption of innocence until proven guilty
8. Right to a fair trial, protection against self incrimination
9. The right to an interpreter

Every law of Canada shall, unless it is expressly declared by an Act of Parliament of Canada that it shall operate notwithstanding the *Canadian Bill of Rights*, be so construed to and applied as not to abrogate, abridge or infringe or authorize the abrogation, abridgment or infringement of any of the rights or freedoms.....

**Know what your human rights are and that nobody can take these away from you.**

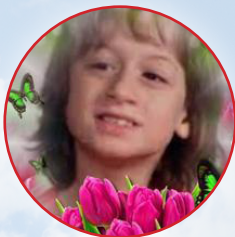

# Letter to my Family, Friends and the People of Canada

On behalf of Protecting Canadian Children, I offer this magazine to all of you, to explain and warn you of the danger for children under the child protection services. I am not the same grandmother that I was before 2004. This grandmother is devoted to all the children in the system even when people in the government turn their back and abandon their duty in the face of genocide in the twenty first century.

Here you will read the real truth that nobody wants to talk about and instead will stop the conversation. No one is more hated than someone who speaks the truth, but the truth must be told.

I pray this magazine will add to the growing wealth of information and expose the truth, to help stop the exploitation of children and to inspire people around the world to see and recognize what the system is really is. Following the atrocities committed to the natives in the residential schools this should be a warning to us all. The same people who captured the world's attention in years past continue to suffer intense persecution. Genocides are by no means a thing of the past.

***Let me ask you: what is your greatest priority in life? If you say "your family" then I say, THIS MAGAZINE IS FOR YOU!***

By all indications, the child welfare system in Canada is operating almost exactly how it did in the 1960s. Today, under different identities and in a different way, we have a new modern era of genocides. The stories that you will read are about betrayal, failure, indifference, inhumanity and evil under their golden rule; "The best Interest of the Child" It is anything but!

The evidence is clear, following years of cases of child negligence, abuse, and many tragic deaths of children. Taking innocent children from their families for profit is one of the most heinous crimes imaginable, often described as modern-day slavery. This crime robs its victims of their most basic human rights.

Once against we are sitting back and are permitting unspeakable horrors to happen to our children, and once again we cannot find the political will to stop it. I pray this magazine will encourage Canadians to RISE UP and say; NOT ONE MORE & NEVER AGAIN. The reign of terror against children for profit must END!

As parents you need to be aware of the risks, families face and be ready when child services come for your children. No one is immune from their claws. The demand for children is high!

I believe in this cause with all my heart and soul. I realized that we had been taken down a path of deception. The horrors of being trapped by the child protective services are unthinkable misery for families. Your right as a parent to direct the upbringing, education, health care and mental care of your child is your fundamental right.

# Child Protection Services – Breaking a Myth

*“Whereas Canada is founded upon principles that recognize the supremacy of God and the rule of law.” – **First line of the Canada’s Constitution, 1982***

*“The Canadian Charter of Rights and Freedoms guarantees the rights and freedoms set out in it, subject only to such reasonable limits prescribed by law as can be demonstrably justified in a free and democratic society.”  
– **Second line of our constitution, 1982***

Our human rights do not come from our government. They come from God, a higher source of law than our government. We are not given our human rights they are ours just for being born into humanity. Know what your human rights are and that nobody can take these away from you.

People think that CPS supports families, but more often they traumatize and destroy them. On the say of one social worker, doctor or child care worker, parents are treated like criminals before they even have due process and a hearing to know what they are accused of, who accused them and the chance to make a defense for themselves. We need to abolish CPS’ seemingly unlimited and unaccountable power over the lives of families and their intent to needlessly remove children from their homes. Anyone involved in childcare work is a mandated reporter—doctors, nurses, teachers, school administrators, social therapists, police officers, camp counselors, all, are pressed into service for CPS.

## **Today this is the least understood field of civil rights.**

Critics argue that child protective services are an institution like prison, masquerading as a social service. Let’s compare family court with criminal court together. Emergency removals of children from their parents’ homes followed by their placement in foster care without a court order is like “pretrial detention.” The “petition for guardianship” that child welfare authorities file against parents is like the charge brought by a police arrest, while the fact-finding hearing before a family court judge is like the trial. Family court resembles a criminal court, complete with a judge, CAS attorneys and court personnel. Parents are called defendants. The custody hearing, where a family court judge decides where the child will stay pending the court’s final decision, is like the bail hearing. The adjudication process, in which the court weighs evidence presented by child family services lawyers against the word of the parents, is comparable to the police testifying against a defendant in criminal court. The disposition is like sentencing. Often the judge just agrees with whatever the CAS says in the disposition, when much of it is unsubstantiated hearsay, irrelevant, science fiction and inadmissible as real evidence. The termination of parental rights? The death penalty.

Family court services feeds into the criminal justice system. Parents and grandparents sometimes go to jail if they resist the apprehensions and 25 percent of foster youth will end up in the criminal justice system within two years of leaving care. As with the criminal justice system, those who are disproportionately affected are black, brown, and poor.

***One group walks around unaware that CAS exists, and another group walks around living in fear of CAS. The system is not broken, it was constructed this way.***

## Child Protection Services – Breaking a Myth (continued)

Parents on trial for child abuse or neglect are lacking legal protections and representation. Parents either don't have lawyers or have legal-aid lawyers who were not paid enough to permit the lawyers enough time to interview the parents, investigate their cases and put up a real defense for the parents against the CPS. Hence parents lacked major due process protections—the reading of their rights, the presentation of the charges against them, the presumption of innocence, the trial by jury, the proof of guilt beyond a reasonable doubt, access to justice, protection from excessive punishment—that defendants receive in criminal court. CPS takes children out of the home based on allegations that they do not even have to prove. This is not a justice system. This is a legal system of a law designed to protect children gone wrong.

The public perception is “we need to protect children from abusive parents,” which is true, but only a small percentage of the parents CPS investigates are even alleged to have committed physical or sexual abuse and most of these families are not found guilty of anything like that. Yet they still take the kids away and put them in the system where many of them are physically and sexually abused by the people taxpayers paid to protect them.

*Protecting Canadian Children* reviews the hundreds of children who died or suffered serious injury through social workers' failure to protect them. We found fault not only with the staff of the welfare system but with lawyers, health professionals, judges and police.

*Protecting Canadian Children* will illustrate the urgency to replace or destroy what has become this dangerous social system that is child protective services. (Based on the work by *motherjones.com*, Dwight Mitchell and the *familypreservationfoundation.org* and our own experience and investigations.)

“The Rule of Law” is a fundamental principle of Canada that “nobody” is above the law, not the government or the child protection services. The CPS is a business under contract with the government of Canada (the people) to administrate the family laws in our country with fairness and with a duty of care. THEY ARE PERSONALLY LIABLE for anything less than protecting our families and keeping them together, safe and only as a last resort to take children from their parents to protect them!

But unfortunately, we have a contradiction to this basic, “Rule of Law” with the directors and employees of child protection services. As the law is now, they seemingly have immunity from prosecution in one section of the law as follows—*The Child, Youth and Family Services Act (CYFSA)*

*Section 133(4): (4) No action or other proceeding for damages shall be instituted against an officer or employee of a society, acting in good faith, for an act done in the execution or intended execution of the duty imposed on the society by subsection (3) or for an alleged neglect or default of that duty.*

***This magazine reveals that the government knew enough about the new genocide under the child welfare of today, but clearly refused to intervene.***

***We put these people on notice and our ministers of government; we promise the families and public that we will get this law changed. No more immunity for drugging, neglect, starvation, sex trafficking and death of innocent children in Canada by people paid by Canadian tax payers to protect them.***

Think psychiatry has nothing to do with you, think again.

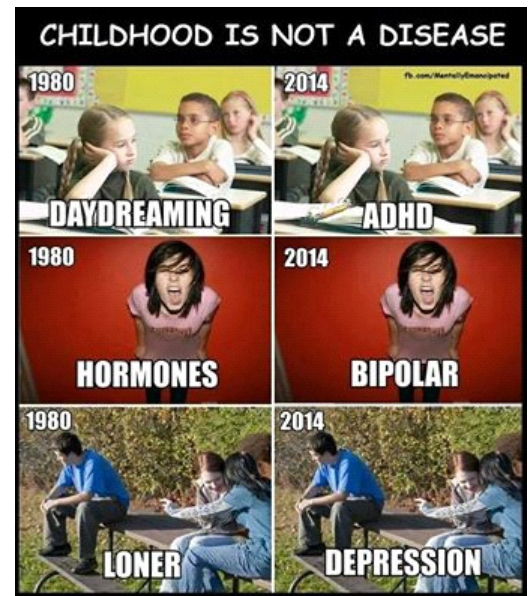

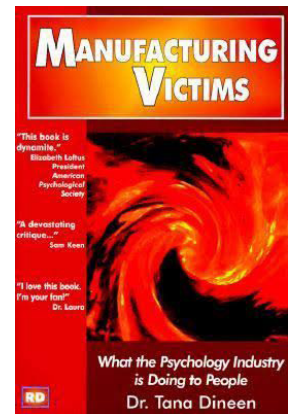

### In British Columbia, Canada

A 9-year-old girl named Ayn was abducted from school by child protective services on June 16, 2011 and was admitted to a mental hospital and heavily drugged with psychiatric drugs. A little autistic girl, Ayn Van Dyk was stolen from her father Derek Hoare and medicated with numerous drugs without Ayn's father's consent. Derek Hoare, does not believe in drugging his children. Ayn is autistic not psychotic. The *Ministry of Child and Family Development* - Province of British Columbia (MCFD) was drugging her with antipsychotics! No claims have been made that Ayn's father, Derek, was anything but a caring and loving parent. The hospital where Ayn was placed reported: We saw no bruises or evidence of physical abuse, and her body status (weight, height, vital signs) showed no evidence of neglect.



Ayn was medicated with:

- Haldol 5 mg immediately at the hospital • Cogentin and Chlorpromazine the next day
- Risperdal 2 mg • Seroquel 25 mg • Chlopromazine 75 mg twice a day • Ativan 1 mg
- Benedryl PRN • Melatonin PRN

They seldom ask the parents' consent to medicate their children with these strong drugs. Informed consent is a fundamental right of medical freedom and good health care. What parent would consent to psychiatric medications if they knew the real dangers of these drugs that threaten not only children's survival and health, but also their emotional well-being for future education and careers?

Children, as young as 7-years-old are receiving electroshock treatments. This criminal cruelty should be prosecuted by the authorities. Children are given psychiatric labels for normal childhood behavior and prescribed psychiatric drugs that drive many to commit violent acts and suicide."

# Parents Engulfed by Unimaginable Terror

Our names are Christine (mom) and Chris (dad), and we have 3 great children with some learning difficulties. Throughout the month of October 2019, we had been packing up our home in Alberta and getting ready for a move back to our home province. In October, 2019 child protection workers showed up to our house at 2:00 pm with police surrounding our house and a helicopter in the air. By 9:00 pm that evening our 3 children were forcefully removed from their home without any legal papers to show court orders as to why or what were the reasons!!! When I asked for papers, I was grabbed by a police officer and dragged outside and pinned to the ground and told I was “obstructing an order to apprehend.”



Fifteen or more police officers, two assessors from child services entered my home and throughout 30-45 minutes I heard my children's blood curdling screams and cries for help until an Emergency Medical Team showed up. I was told they administered something to my children but they wouldn't say what. Nobody asked if the children had any allergies or disabilities or medical concerns, but my children went quiet. One EMT worker came to me and said my middle child wanted to speak to me. My daughter came running outside shaking, crying and squeezed me telling me she pee'd herself and she's scared to death!!!! She said that they hurt her and sissy and her brother, by grabbing, throwing, pinning and dragging them!!!! (These are children who had never been spanked or handled violently by their parents.)

Throughout all this I had been dragged, pushed and pinned by police officers. I tried to call for help and they threw my phone breaking it. Chris (dad) had been pinned by at least 10 police officers to where he has been spitting up blood, his back and chest were injured. One police officer tried to help us parents. “I know these people, she said. They are not bad people.” My son came running to his father who picked him up to hug and comfort him when police officers struck Chris from behind and he dropped our son who hit his head on the ground.

We went into the house after they took our children and every light was on. Every closet, dresser, cupboard door was open and a lot of things were missing. My children's medical records, medicines and belongings were missing. All packing boxes had been torn open. There were holes and damage in walls, doors and the ceiling. The master bedroom where my children were ripped from had holes in the ceiling, the door was hanging off and the door frame came down with it.

Over the next four days my husband and I worked together sending out 350 emails to ask for help for our family not even realizing four days went by. We were supposed to move out of province on the 30th of October and now child services told us, our children won't be going anywhere for a long time. I don't know what we did or why this is happening!!!

***This is a well-documented problem from hell. This is a clear and convincing proof that genocide in Canada isn't history, it's reality under the guise of foster care and group homes where children are grossly mistreated. What if your family is next?***

## Owen's Story

Owen, 8 years old, Mr. Meteorologist, as his family smilingly describes this observant child who loves to sit by a window and look at the changing weather conditions.

Six-year-old Owen was sexually and physically abused by the principle of his Catholic school. The parents complained to the school, the school board, their doctor, the Bishop, the local police, the Minsters of Education, and the child protection agencies CFS of Alberta. The child actually had Herpetic Whitlow on his fingers and face which a dermatologist prescribed a medicine to treat.

No one has been held accountable for this abuse of power a Principal would have over a young student at school. Instead this investigation was closed down, the CFS have turned on this family and made their lives hell. Sam was placed in a facility for children with mental and behaviour problems away from the two sisters who love him. Across is a picture of the boy's fingers covered with the Herpetic Whitlow.

**JUST IMAGINE** if this were your child? Put yourself in their shoes. Family abduction under the child and family services is the most prevalent form of child abduction in Canada. It is an illegal act that has lasting consequences for the abducted child, and the parents. It is a crime all across Canada.

The abduction of your children under a government/privatized corporation to feed an enormous child protection business is one of the most devastating and frightening crises that a parent could ever encounter. This family is fighting with everything they have to save their children's lives.

**At the end of the day our children were violently removed. Our children were dragged, cuffed and shackled where skin rolled up on their legs and feet dragging them across the carpet. Our 15 year-old daughter was body slammed. Our two daughters were then brought to an underground facility where they spent the night crying while restrained to dirty, plastic mattresses on the floor where they cried for 5 hours before falling a sleep. Our little boy has been put in a mental facility but he is not mentally ill and all three children are being drugged and the girls are separated from our son.**

*Imagine the parents not being able to protect their children, not knowing where they are and facing an onslaught of police and 2 social workers terrorizing your kids and damaging your home while you are restrained to watch it all happen. Using police forces like this in a democratic society are we living in a police state?*

## Linda's Day in Court

I travelled to Alberta to support Christine and Chris's family. I wanted to offer to take custody of their children because I was and am afraid for their children's lives. I have never met this family before; my only focus was to keep these children safe. I have attended inquiries and family court before, but I was not prepared to see and witness the devastating and horrifying effects of ignoring family mistreatment under the child welfare in Alberta when an associated group of child protection hypocrites ban together to gain power over targeted families, while using a mask to fool the public. No one can ever be prepared for their merciless and horrific conduct toward vulnerable families.

Later, I attended their trial for temporary guardianship of the CFS over their children. I was near paralyzed by their pain and fear and then witnessing the CFS employees acting as important, authoritarian officials.

I wanted to vomit. As a citizen of this country there is no doubt Canada and the next generation are in trouble. NO ONE IS SAFE! And EVERY SINGLE FAMILY IS IN DANGER of abuse by these agencies supported by the government. Before, entering the courtroom I watched the child family service (CFS) people carrying boxes of evidence, parade through the hallway and into the court room. I thought I was attending the trial of a big criminal.

When in court they took a break for 10 minutes and the lawyers for CFS came over and told me to leave along with another witness. Then I thought I would return back because in my view it was the judge's job to ask me to leave. One of the lawyers was nice, but the other one her tone was nasty and demanding as if to say, I am in charge. If these lawyers were sincere about the welfare of the child, they would welcome any honest person to attend to protect innocent children. When the judge returned the court was adjourned because of a technicality.



What followed displayed a chilling image and true picture of what child and family services, the family court, and the police of Canada have become--a police state and a communistic society. There is no other explanation. The couple were both arrested but the sheriffs didn't know what the charges were for or if there were any charges but they arrested them anyway. I was horrified watching the scene. It was like show biz with them all strutting officially, the sheriffs in their uniforms and badges taking this couple away to be processed for charges that did not even exist yet all arranged by the vexatious CFS social workers to harass and intimidate the parents of these children.

Parents are presumed guilty and punished before getting a chance to defend themselves. Few lawyers will defend these families. They "Yes" the CPS instead by telling the parents, "You have to do what the CPS says and maybe you will get your kids back." No, the lawyers need to really defend the parents against an injustice of their Charter Rights, and restore their kids to them.

# The Role of Social Workers

They are charged with the most essential of duties: protecting vulnerable children from abuse and neglect. I feel profound sadness at the fact the social worker system, as it applies to children, is seriously out of control, we have a “culture of non-compliance with policy” among social services staff. They think and ARE doing whatever they want. They were given free reign to overly abuse their power. They lie to conceal their cover-ups. Any kind of abuse or fraud is an offence.

## THE SOCIAL WORKER PROFESSIONAL OATH

I solemnly pledge to consecrate my life to the service of humanity and to social justice; I will practice my profession responsibly with conscience, integrity, and dignity which are consistent with its values, ethical principles, and ethical standards; the welfare of my client will be my first consideration...

## ON THEIR WEBSITE

The Ontario Association of Social Workers says the role of social workers is a profession of hope, a passion for fairness and that the social worker’s job is to help people.

***The primary target of our blame is the Prime Minister, and his cabinet who administer the government departments in our country. They and they alone are making life-and-death decisions that dictate Canadian policy.***

## PROFESSION BY PROVINCIAL LAWS

Social Work is a regulated profession by provincial laws. The legislation is called the Social Work and Social Service Work Act, 1998, in ON and is overseen by the Ministry of Community and Social Services.

I am always surprised at the audacity of social workers dealing with vulnerable families in the way they talk and posture, intimidating and threatening the parents, already stunned and devastated by the removal of their children. Statements, while pointing to their chest like, “Your grandson belongs to us now.” “We are untouchable.” “Back off we’re in control now.”

Parents are told not fight with the social workers or it looks bad for you but the social workers often provoke the parents into anger. I have personally witnessed the process of “Gaslighting” used by social workers on the parents, trying to make them feel inferior. They use thousands of pages of a deposition to be used in court against the parents to justify why they took their children away. The deposition is often fiction, full of lies and perjury, even after taking an oath to tell the truth.

Witnessing their lies in court and in their conversations with families for me was like a cold knife of panic and disgust sliced through my gut. Witnessing the “NO” justice in court and the people who we trusted breaching their oath for their own interests goes beyond disgust. It is perjury and a very serious criminal offense; they disrupt the legitimate discovery of truth.

EVERY DAY the agency of child protective services is too aggressive in removing children from parents and allows social workers to twist facts without consequence knowingly giving false information to the judge to terminate or recommend the children be placed in foster care, stripping the parents of their rights. It is an unfathomable violation of the trust that the people put in place in their public servants.

***The children’s aid in their sworn testimony and deposition lie and fabricate stories about the families. Perjury and fabricating evidence are serious offences under the Criminal Code.***

## The Role of Social Workers (continued)

### Failing Chancey Miller – Incomprehensible Nightmare

Having a sick child is frightening for most parents. Caring for your sick child comes naturally to parents. They know how to soothe a sick child. For example little things like holding hands, reading bedtime stories, saying positive things and appearing in control are some of the things that can go a long way in reassuring a child and often speeding up the recovery process. On the other side of the coin, a sick child feels more secure in the comfort and familiarity of the family circle - having Mom there to look after them.

Chancey Miller was a beautiful little girl who, at the age of three months, it was discovered that she had been born with heart problems. She had to undergo surgery in Halifax to have a pacemaker implanted. Chancey was removed from the Miller's home by the province's child protection division. A social worker saw a photo that her older daughter took of Chancey with her father, who had been ordered to only have supervised visits.



The doctors at the Janeway Hospital in St. John's referred Chancey to the Sick Children's Hospital in Toronto because of problems with her pacemaker. It was determined that she would need surgery to have a new pacemaker implanted.

This would be a scary time for any parent and child. It is absolutely crucial for any child that has a serious medical condition to know that he or she will be getting lots of care — especially for a three-year-old girl in a hospital; it must be very frightening. Most often the best medicine for a child during treatment and recovery is to get better with the support of a mother's love and medical clinicians. When one is parenting alone, any support possible is always appreciated. This was the case with Chancey's mother, in another province all alone, except the child protective Services helping them out.

For most of us this is no mystery to us, as to why Chancy's mother was not a part of the move of her daughter's care to Toronto. Far more serious, however, why, would the social workers ever keep the mother away from her child in this crucial time, and put this little girl in foster care? What kind of services were these social workers providing? Where was their compassion and kindness? Is that something they received as part of their training?

I believe the Social Service Worker Program provides you with the skills and knowledge to help struggling people, helping families in social maladies in all aspects of social and medical services as well as in many other fields. The physical and psychological well-being of a sick child is, and should be, paramount for the entire medical and social worker team.

**So, WHY IS IT that this mother and child HAD TO DEAL WITH DESPAIR SEPARATED FROM EACH OTHER?** This little girl had to DIE WITHOUT HER MOMMY AT HER SIDE in another province? This was a traumatic end for both mother and child.

Now imagine being the mother and told by social workers that Chancey died in the hospital from an infection, while a doctor in Toronto said she died at the foster home. The mother saw a report from the Toronto hospital suggesting that Chancey's condition was getting worse, describing a possible heart transplant. Who would you believe? Why two different statements?

What is clear in this case, as in so many others, and almost equally alarming is the way the system manages to shield itself from the community review, through reporting restrictions which it claims are designed to protect the children but which too often end up by protecting only the system itself for "profit." Children are human beings and have the right to life, to be protected, and loved. They are not commodities for government run agencies.

This child was separated from her mother who loved her during this critical time in her care after heart problems. After the operation the child stayed one day in the hospital and then was moved to a new foster family north of Toronto. How is a mother to visit her child so far away from her? When the child died the hospital blamed the foster parents and the foster parents blamed the hospital. Dear Reader could we have done better for this child and her family? Did this mother ever hear the real reason for her daughter's death? Often the details, medical records and coroner's reports are hidden from the family.



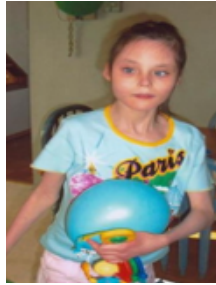

# The Story of Samantha Martin

*Hello my name is Samantha Lauren Martin. I am an angel now, with a message to you.*



My physical neglect goes beyond bruises and 7 broken bones. My injuries in various stages make it obvious that my physical harm did not occur as a result of a singular accident. Bruises, marks on my face, bite marks, broken bones, missing hair was visible indicators and clear evidence of willful neglect and ill treatment. I was ignored by child professionals.

Clearly from the list of government officials contacted they did nothing to save me from abuse, starvation, neglect and death. Who has the legal ability to make changes in the face of such horrific maltreatment?



My mother, Velvet Martin, spent 3 years, 2 months - prior to my death - attempting to alert officials of concerns. This is the list of organizations that she alerted and communicated with:

- Caseworkers, managers, directors of Edmonton & Area. Inquiry Region 6,
- Senior Operating Officer of Child Intervention, Senior Manager of Child Intervention Specialized Services,
- Senior Operating Officer of Community Initiatives, Information Officer,
- Ministers of Child & Youth Services (from current Minister to two previous Ministers who held Office),
- Minister of Justice, Law Society of Alberta,
- Lawyers,
- Edmonton Police Services, RCMP,
- Chief Medical Examiner, Medical Review Board, Ombudsman,
- Premier, Governor General of Canada,
- Various Advocacy groups,
- Medical personnel, Superintendents & Staff from various schools and districts,
- Transportation,
- Office of the Child Advocate and Metis Child & Family Services

A "Mandatory Notification to the Children's Advocate from a Child Welfare Staff Member" was completed on January 27, 2006 and submitted by Natasha. The reason for the notice stipulated that "The child might have been emotionally, physically or sexually abused while in care" and Natasha marked the box that read "I believe that the child's needs are not being met; the child's rights are not being protected; the child's viewpoint or interest is not being considered; or all relevant information is not being considered." Under additional information, Natasha documented the information she had collected from the referral source and staff at the Fort Saskatchewan District Office.

When the staff member believed Samantha had been "abused emotionally, physically and sexually in care," the agency should have immediately removed Samantha from the placement. It was a miserable decision to deny an investigation in this case. I hope these people will be judged, and judged severely. Allegedly three other children died in that same foster home and it is still open. This home in my opinion should have been placed on a blacklist which should not receive more children because of poor standards of care.

## The Role of Social Workers (continued)

I personally attended several court cases where children were not protected by child protection services. Many children are taken from parents who love their children and want them home and have no history of abuse. This is negligence of duty on their part!! This is a tragedy not only for the immediate victims but for hopes for a better future. As a grandmother it is frightening to envision what the next generations are up against. We need to take back “OUR POWER and RIGHTS” because these types of organizations are only interested in money not solving the root causes of family problems or caring for helpless children!

Under administration law our front-line workers – social workers, police, lawyers, judges, teachers, doctors are under more responsibility to deal with our families in Canada with a fiduciary duty of care, and unbiased procedural fairness. Under this ministry the professional workers are failing miserably, and for so long. WHY? Hypocrisy at its worst.

## Failing the Children that Should Have Been Rescued

If I have written something here that offends you, bear in mind that you probably have not looked at the structure of the child welfare system under a microscope. My discovery led me to believe some Canadians have lost their heart for humanity. There is no BS in this magazine. It is raw, no sugar coating, presenting some “gruesome” statistics.

It is the responsibility of the Executive Director of children’s protection services to preside over the organization’s day-to-day operations. It all falls on the leader’s shoulders. The rot starts at the top of organizations. One can’t only assume that these abuse cases under their care are just the inevitable result of an impersonal bureaucracy acting as a safety net for children.

We know in some cases foster care is necessary. Cases like two-year old Marissa Whalen (under the supervisor of Family and Children’s Services Niagara, Ontario), seventy-five calls went into the child services to protect Marissa and they failed her. Jeffrey Baldwin starved to death in the care of his grandparents all under the supervision of children’s aid in Toronto and they failed him. Five-year-old Phoenix Sinclair, was another huge failure of the child welfare system. Then the union tried to stop the investigation into this case. This represents the degrading of the dignity of a child as a human being!

Unless you’ve been targeted by child protection services, you cannot even begin to imagine the feeling of pain, grief, financial loss, helplessness and depression caused by having your children removed without due process, and the nightmare involved to get them home again.

For many parents the child will never come home again and you may not even know the real truth of what happened at the end of your child’s life. Records and documents are often kept secret.

## Brainwashed

Under the child services the children are reportedly brainwashed in foster care. Care workers often alienate the children from their parents and tell the children their parents are bad and they don't love their children. One of the worst things you can do to children is alienate them from their parents who love them and want them home. Brainwashing is a severe form of social engineering that combines words and actions along with isolation and dependency on the workers for their daily needs.

We have seen many good social workers who try to help children and make a difference in their lives, but often these good social workers

are fired like the social worker who tried to help 4 year-old, Serenity Rabbit. She was fired. For those people who have a good heart they cannot work in this system and be a part of doing harm to parents and their children when they know so well how to do the job better with mercy, compassion and kindness. Good social workers often will suddenly quit their jobs to leave the industry and seek work that they can live with. How can the industry keep a good social worker? If they report that the parents are good parents, the social worker would have to give the kids back.

Like-minded professionals experience the same choices like Alberta's former chief medical examiner, Dr. Anny Sauvageau wrongly dismissed who said, "My soul is not for sale." Teacher and Justice of the Peace, James Black wrote reports to his school board to make them aware of how many pedophiles were being hired as teachers in the northern schools. James was fired instead of the pedophile teachers harming children.

Most social workers are government employees, civil servants, and all are paid by taxpayers. Most front-line child protection workers are members of government employee unions like CUPE. Evidence of this is in the employees' union files where a motion to suspend the inquiry of 5-year old, Phoenix Sinclair, of B.C. on 6 February 2012. Phoenix Sinclair died on June 2005 while in care.

The Canadian Press – Posted: Apr 22, 2013 Disturbing to say the least! *Why would the union want to suspend an investigation into the death of a child? Who is responsible for this child's death? Does our silence contribute to the problem?*

Why would anyone be allowed to even decide to not investigate the death of a child? The union's values are offensive. One can only conclude that they don't value the life of this 5 year-old. This type of behavior just makes the public more suspicious of irregularities that go on with the death of children in protective care.

Canadians need to face and understand the truth. Corporate child abuse and abduction, surpasses all other forms of child abuse put together. Therefore, when abuse takes place in care under the supervision of our government employees and they turn a blind eye to the abuse, the employees have significantly failed in their responses to child abuse. This has happened for decades. These workers are personally liable for these crimes, these workers have a duty of care to these children. Where does the professional association of social workers stand on these matters? Where do the colleges and universities stand on this issue?

Detroit mother Maryanne Godboldo made international headlines when she refused to administer a dangerous psychiatric drug to her daughter, resulting in child protective services (CPS) assaulting her civil and human rights to the extent that many could not believe this could happen in Detroit. The truth is any parent could be targeted by the mental health system via CPS and lose their rights as a parent. Maryanne was a single mother and former dance teacher who had never been in trouble with the law and had never even had a parking ticket. She refused to give her daughter a harmful, potentially lethal antipsychotic drug documented by international drug regulatory agencies to cause diabetes, stroke and death. Her daughter became uncharacteristically aggressive on this drug. On March 24, 2011, Maryanne Godboldo barricaded herself in her home for 10 hours, standing off a Detroit police unit including a SWAT team, a tank, a helicopter, and sharp shooters carrying assault weapons on the roofs of the other buildings, seeking to kidnap her 13-year-old daughter Ariana. CPS worker Mia Wenk, who had only a bachelor's degree in criminal justice, had decided that Ariana needed to be kept on the dangerous medication Risperdal despite its negative side effects on Ariana.



New Oakland Child-Adolescent and Family Mental Health Facility where Ariana was seen was paid by pharmaceutical companies including Johnson & Johnson, the makers of Risperdal, since at least 2004 to do clinical trials on adults and children.

Wenk went to Wayne County Juvenile Court and had a probation officer rubber stamp an illegal “court order” for Ariana’s removal. She then recruited cops she knew, who went to the house without paperwork to take Ariana. Maryanne adamantly refused to give over her daughter. The cops illegally and unsuccessfully tried to break in without a warrant, then claimed they heard a gunshot inside the house. Soon, a tank was rolling down the street with a helicopter flying over the neighborhood, and police armed with assault weapons took up positions on the roofs.

Maryanne finally left the home after community supporters said they were afraid she would be killed like seven-year-old Aiyana Jones was in a similar raid in 2010. The girl was shot in the head while she slept on a couch during a 2010 police raid. The police and CPS negotiated with Maryanne and assured her that they would not take her daughter to a psychiatric ward, or administer drugs to her. They lied. Maryanne went to jail and her daughter went to a mental hospital.

Ariana was kidnapped and taken without parental consent to Hawthorn Children’s hospital for six weeks. There, the child was medicated with FOUR psychotropic drugs, forced to removed her prosthetic leg which she had worn since she was an infant, and allegedly was subjected to sexual assault.

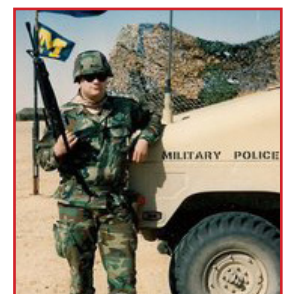
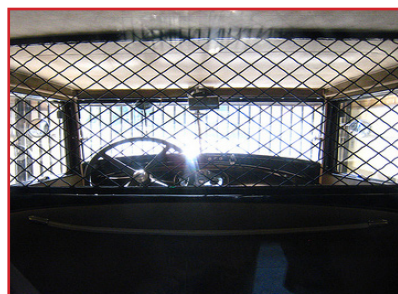


Detroit used their MILITARY against a respected, single mother. BUT CANADA look what happened similarly in Alberta, 2019. A family's neighbourhood was surrounded by police cars, with a helicopter above. More than 20 officers came to the home to apprehend the children. The parents and children were violently restrained and EMS workers drugged their kids. A similar case was reported to us from Moncton, NB. 2019. We are appalled and disgusted when this much unwarranted force can be used against families. This police behaviour would be reserved for criminals and terrorists but is unthinkable for citizens in our democracy. Are the citizens their enemies? Who allowed this to happen to us?



**“ATTENTION LAWYERS”:** Award winning, Civil Rights Lawyer Allison Folmar, defended Maryanne in court with the help of Citizens Commission on Human Rights, a “watchdog” organization that investigates human rights violations in the mental health field. Allison went to the mental health facility where Ariana was being held and brought her home. Lawyers in Canada need to do this as soon as kids are taken. Allison went on to win 29 more cases and she now trains lawyers on how to do the same. There is money to be made challenging the child protection services and bringing these children home to their parents where they belong. Foster care is the funnel for child abuse and child sex trafficking. The numbers of children being trafficked from Canada and the US is staggering. Kids in foster care need to be apprehended and rescued before they suffer permanent harm.

I have tremendous respect for military, but we should all be concerned when child protective services are turning to the military to apprehend children, traumatizing the children and treating the parents like hard core criminals. CPS will stop at nothing to get their hands-on innocent children. It is horrific and appalling. Who is the real abuser here?





# The Tragic Scandal of Forced Adoption

## “Punishment without crime.”

The fact is that parents who have committed no crime are losing their children to forced adoption — a despicable act! Forced adoption, is not only illegal, it is a crime against humanity for which the judges who order it should be put on trial.



Adoption should represent hope for orphaned children, hope of having a loving family, hope of a future. And sometimes it is. But adoption, like any other social process, adoption can become corrupted.

The kidnapping or unlawful buying/selling of an infant or child for the purpose of offering that child for adoption represents a serious criminal offense. According to the **United Nations Protocol to Prevent, Suppress and Punish Trafficking in Persons**, a child adopted by families without the biological parents' consent is considered a victim of human trafficking. The Protocol was adopted by resolution **A/RES/55/25** of 15 November 2000 at the fifty-fifth session of the General Assembly of the United Nations. On May 13, 2002, Canada accepted and joined in the resolution. Sadly, this protocol has been ignored for decades.

## Bill 179

May 16, 2010, I delivered this speech at Queen's park to oppose this unconscionable bill (an excerpt from my speech below).



Dealing with Bill 179 it is really a question of following the money. Who profits?

*“I would like to know who gave the right to the Minister of Children and Youth Services, to mastermind and present a harmful Bill against our families? Who gave the Minister the right to propose this Bill only to serve the huge money-making industry of children's Aid? The Minister's job is to protect the children; not to put them for sale!! She is creating, and supporting crimes against humanity, and holding herself unaccountable.*

*It diminishes a child's right to it's own family life and risks the early separation of siblings. Justice must never be sacrificed upon the altar of speed.*

*Bill 179 give rights to apprehend children and farm them out for adoption all within a 30-day period! A newborn baby with a mother who is arbitrarily deemed to be “at risk” will quickly become a commodity, and any chance for a troubled mother to regain her child will simply disappear. To speed up the adoption process, we are at risk of rushing through more of these adoptions, despite serious concerns on whether this is the best option for the children involved. This opens the door for more abuse by the Children's Aid society to obtain a huge supply of newborns for the adoption Industry. This is taking us back to the Baby Scoop Era of the 1950's and 1960's.”*

Ontario Bill 179 provides for foster parents or anyone to adopt a child (and CAS will pay them \$18,000 a year). A very powerful and dangerous incentive.

Trafficking and exploitation of people costs lives, but earns a lot of money—for individuals, organizations and governments. I do not applaud the government for its introduction of Bill 179. This Bill gives the CAS sweeping power to capture more babies.

# This is the Story of Delonna Victoria Sullivan

**Born: November 23, 2010–April 11, 2011**

Delonna Sullivan was a healthy four-and-a-half month-old baby when child and family services of Leduc, Alberta, took her from her mother and placed her in a foster home. Six days later she was 6 lbs less and dead. No one has been charged or held accountable.

On April 5, 2011, about 9:00 a.m. there was a knock at Jamie Sullivan's door. Two child care persons and an RCMP officer were there with apprehension orders for the children of her female roommate. They took the roommate's children and then an hour after that showed up at her door without a warrant and demanded Delonna.

The autopsy attributed Delonna's death to "sudden unexplained death in infancy." Delonna's mother and grandma continued to ask questions. They demanded the medical file, which revealed that the foster person put Delonna in an infant carrier at 10:30 a.m. and never checked on the baby until 3:30 p.m. The file stated that Delonna had a cardiac arrest at approximately 12:00 p.m. As her organs slowly shut down, how long did she lie dead before she was even noticed? The toxicology report revealed there were four different drugs in Delonna's system: acetaminophen, chlorpheniramine, dextromethorphan, and pseudoephedrine. These are all cold medications that are unsafe to give to an infant under two years without consulting a doctor. The hospital took two sets of hand and foot prints; they had the audacity to give the first set to the foster woman. Delonna's mommy never received the second set.



## LEGALLY SPEAKING:

- Child removed under false pretences, a baseless independent whim of a single social worker. No evidence or investigation.
  - Illegally, removing a child with no court order is a crime against the child's parents, and the child.
  - "Aggressive threats of violence to the mother while illegal kidnapping her child, is a felony.
  - Child stealing for adoption and profit is a felony (2 days after taking Delonna, the CFS made a call to the uncle and asked if he wanted to adopt baby Delonna.
  - The social worker placed this child in danger, where a foster mother was not suitable, is criminal negligence also against the child and its parents.
  - Another failure to provide the necessities of life (medical attention-was denied by the CFS and the foster mother after the child was obviously very ill.)
  - Criminal negligence that leads to death is a crime. The baby lost 6 lbs in 6 days, had severe diaper rash and could not lift up her head. Two days prior to being apprehended this healthy, happy baby was at the doctor's office weighing in at 19 pounds for her proud mother. (Natural parents would go to jail for this, but not the CFS and foster care parents, they go free.)
- There was no warning call, no warrant, the social worker and the RCMP just took a healthy baby to her death. She died of a slow death of starvation and dehydration. I consider this to be one of the most egregious violations of parents' most basic Constitutional protections.
- This is a total failure of Humanity in Canada. Delonna died under the command of the Family & Community Support Services in Leduc, Alberta.

*If this is not pure evil, I don't know what is!!*

## This is the story of Delonna Victoria Sullivan (continued)

NOW, IMAGINE, watching powerless unable to protect your baby in your own home. NOW IMAGINE your baby died after begging for medical attention from the child and family services. Medical attention was denied. NOW IMAGINE walking in the morgue to identify your baby. NOW IMAGINE when showing emotions a police officer threatening you to put you in a mental hospital or jail. Callous to the core! NOW IMAGINE the villains are above the law and well protected. JUST IMAGINE! When parents tell me their story, they are overcome with inconsolable grief drowned out in a torrent of tears. Delonna died of neglect six days after being in care and was denied medical attention. To view her story, go to; *Friends of Delonna* on Facebook.



The foster person (we can't bring ourselves to call her a mother) was so upset that 10 days after Delonna died, she went to Mexico on holiday, you paid for it dear tax payer, and we saw her in a bar having fun, posting all over Facebook—she is open for business. She later tried to sue the child's family. (Chilling to write this story)

I attended the 4-day hearing which resulted in a 5-page fatality report. Disturbing to say the least! There were no recommendations by the judge. It must be a really tough job, writing 5 whole pages after a week of listening to testimony. Delonna was 19 lbs at removal from her mother (doctor's report), the judge said Delonna weighed 13 lbs at death. The report said that the baby's death was a mystery. Is this a mystery for you dear reader? Maybe it would be a good idea to



get these transcripts and point out these discrepancies to the public, and have an open inquiry as to why this judge would be so accommodating to absolve the child protection system of any culpability. There were a number of discrepancies from the inquiry compared with what was reported in the news. As far as I am concerned, my personal opinion, this judge should be fired immediately!

**PARENTS ATTENTION:** Please accept this advice from Delonna's mother and grandmother. If you see your child sick and in need of help call 911 right away and wait for them to arrive. The ambulance drivers will give medical attention right away and rescue your child. They cannot refuse to help you. This reality is horrifying. Delonna was taken by force and allowed to die alone. Her foster mother is guilty of "criminal negligence causing death." A parent would face a long prison term for this.

Recently in NB medical treatment was denied to a child in foster care sick with fever and vomiting. PCC NB, Sylva McLaughlin called an ambulance for this child and when the ambulance arrived the police would not let the paramedics examine the child.

## Forced Adoption – Punishment Without a Crime

What happens to children in our country when taken into protective care? Many people believe a nice family adopts these children and gives them a good life; one they would never have the opportunity for if they were helped to stay with their families of origin. Wrong, most cases do not end like that. Many people believe that families did something really bad to lose their children. Wrong, many do not deserve to have their kids taken from them. Many people believe that these families are guaranteed their Charter Rights, freedom of conscience, religion, freedom of thought, belief, opinion and expression; freedom to move and work in any province or to enter or leave Canada; the right to life, liberty and security of person; the right to be secure against unreasonable search and seizure; the right not to be arbitrarily detained or imprisoned; the right upon arrest or detention to be advised of the reason for an arrest and the right to call a lawyer. When children are apprehended a family has the right to know why and to be presumed innocent until proven guilty. And families have a right not to be subjected to cruel and unusual punishment in this country.

Under the *Child, Youth and Family Acts* of our country these fundamental rights are trampled on, and you are instead presumed guilty on the testimony of one callous accuser, punished in spite of the fact there is no crime and subjected to cruel and unusual punishment when your children are apprehended from you. *Protecting Canadian Children* gives you a chance to see their concealed horrors, hidden cruelty, master destruction and organized insanity.

**Amira Kandzic from a Bosnian family** had her son Almedin taken in 5 minutes, by Children' Service's Niagara. I personally attended the court.

More chillingly, parents have been told by social workers they must lose their children because, at some time in the future, they might abuse them. Such is the case of a Williams Lake, B.C. couple. The mother who gave birth at the hospital had her baby taken after hospital staff called the provincial Ministry of Children and Family Development (MFCD) to report that the mom was neglecting her baby 90 minutes after having a C-section. There can be no justification for this. "Why did no one question their audacity?" *National News* — June 28, 2019 by Melissa Ridgen. 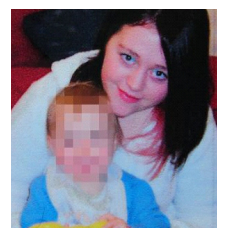
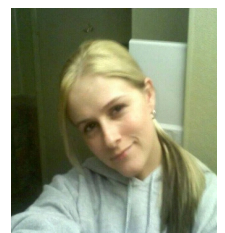
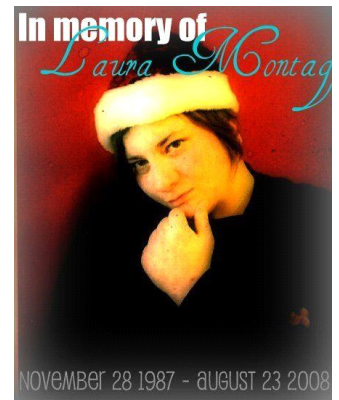
Laurie Mantag - It has been 12 years since I lost my daughter to suicide. She was my wild child (my first born). When she found out she was pregnant in 2007 with Julie, she moved back home to live beside me. CAS tried apprehending Julie because of Laura's past not her present, they failed. Unfortunately, Julie died from SIDS (Sudden Infant Death Syndrome) at 7 weeks. After Julie's death CAS admitted she was doing nothing wrong. So we assumed her file was closed. We all encouraged her to get pregnant again. In 2008 Michael was born with some medical issues including spina bifidia. This did not concern her she was just happy he was ok. In comes CAS again like a dirty shirt. In the month she was at the hospital while he recovered from surgery, CAS hounded and harassed her daily, to the point the hospital staff told them they were not welcome unless she had family present. She was only home a week with Michael, and she committed suicide. CAS may as well have put a gun to her head, they were out to get her. She left a note stating she felt the only way they would leave Michael alone is if she was not here.

# Baby Snatching at Birth

I decided to witness a baby taken at birth in Niagara Falls, Ontario, with my friend Maggie Steiss, at the Family and Children's Services Niagara (FACS). I wasn't ready to witness the most cruel inhumane acts carried out by a system that was created for the "best interest of the child." I was out of control begging police officers to take a stand. They were witnessing "crimes against humanity." I told the lady police officer, I was told by my parents "you need to protect your children with your life if needed." Therefore, if this was happening to me before I let my baby go, "you would have to shoot me." It is as simple as that!

I was stunned to see their casual behaviour. They were all willing participants. Forced adoption is a crime against humanity and those social workers and judges involved should serve long prison sentences. Family court judges who order forced adoptions are themselves criminals who should ALL GO TO PRISON for a very long time!! Up to this day I am still haunted by that day. I will never forget the painful agony of the mother and I felt so helpless. I was forced to face the reality these workers are part of a system where it seems they, the court, and the police are too often conspiring to abduct children from loving parents in the name of what amounts to heartless "social engineering." I could have never imagine (this could happen in Canada). The snatching of children is feeding a high profitable forced adoption industry that is in full swing and running out of control in our good country Canada and globally.

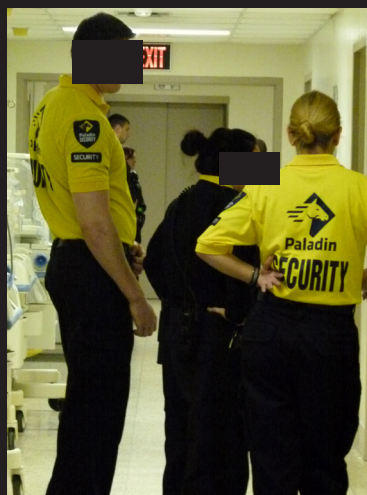
Doesn't this violate the child's rights under the "international humanitarian law" and should they not "ensure that it doesn't happen again?"

## Letter Submitted by Lori Pynn – March 2020

Here is one family's story where the children have been taken in an illegal, lucrative supply chain for adoptions. This mother, Lori Pynn, is perfectly healthy and capable as a mom. I met her personally and she told me; "It's a lifetime of grief and yearning that goes beyond price." Forced adoption destroys families' home and sows quiet terror throughout Canada for parents.

This is the story of Lori Pynn From St. John's, Newfoundland and Labrador.

In September/09, approximately a half dozen social workers, and another half dozen police officers came to my home to apprehend my 5 children, ages 7 months – 9 yrs, a parent's worse nightmare!

I know you must be thinking "I must have done something?", and I did!. I was uneducated, poor and single mom on my own with my 5 children, however, I had the support of my family and friends, something the child and family services never acknowledged. My history of being in foster homes, and past history were also held against me. I also firmly believe that decision pertaining to the apprehension, was made on a personal whim. I very much dislike the CYFS, for their continued disrespect, indignant and heinous behaviours toward me. I was berated and criticized at every level about my parenting. For example, I enjoyed co-sleeping, I implemented limits/freedoms, bed times, what I feed them, everything I did I was told I did wrong. I do not drink or do drugs, my home was always tidy, always food, always kisses and hugs.

I was tired and sometimes overwhelmed with adjusting to two infants, but I was happy, my children were happy, and my family and friends were happy for me.

So with a warrant, a warrant they couldn't get the day before, so had to take it to a court clear across the province, they were legally able to come to my home, and steal my children.

A trial took place Feb/10, presided by Justice Wayne Dymond, it lasted a full 2 weeks. The judges decision came a few months later in Jun/10, which ordered my 3 older children home to me, but my one year old twins were to be taken away into forced adoption. How can they send 3 children home, and kept two? When you know the answer, could you please tell me?.

Ten years has past since myself and my children have seen our precious twin babies. I don't know where they live, if they are loved, if they are alive. Despite the horrific experience with my family, myself and my other children have overcome a lot of hurt and trauma. My kids at home are good kids, they are hard working, kind, smart, funny and have dreams and goals for their futures.

I myself am only to get up every day and go to work, tend to the house/chores/errands of everyday life, by Never thinking of my babies.

I'm trying to set an example for my children, that no matter how hard life gets, how bad someone treats you, that there is always hope.

## My Story – Ian Josephs

My name is Ian Josephs, (BORN 1932). I have a law degree from Oxford University and in 1961 I was the youngest member of Kent County Council. A mother asked me to help her recover her 12 year old son from Council care in an outrageously expensive private school owned and run by the Deputy leader of the Labour/Socialist group on the Council His mother was refused contact and so was I but when I eventually saw the boy (after a lot of publicity from the National press who were very supportive after I alerted them) the only nice thing he could say about this very down-market school was that “the money was very good !” He was, he said well paid for sleeping with his teachers!

Suffice to say I helped get him out and later found myself opposing my own Council by representing (free of charge) many Kent parents in court whose children had been taken into care mostly for school absences and petty misbehaviours and who had read about me. I never lost a case (the family courts in those days were very sympathetic to parents!) but it took up so much time that my language school ran downhill as did my first marriage so after 6 years in 1967 I did not stand for re-election and concentrated on my business and my second marriage.

Years later, in 2003 there was a scandal when Professor Meadows wrongfully accused mothers of murder and got them convicted when they were later found out to be natural cot deaths. I wrote to the Daily Mail saying that things seemed worse now in “child protection “than when I was involved 50 years earlier. They published my letter and I received via the paper an avalanche of requests for help from parents whose children had been taken into care or adopted by strangers. My situation had improved vastly by then with a successful business and a very successful second marriage with 5 children. By then, I had time and no financial worries so I looked into how things had changed with child protection. I found alas that they were very much worse!

The Children Act 1989 hailed at the time as parliament’s finest aid for children was in fact a 6 point DISASTER!

- 1) Councils were encouraged to take children from parents who had never committed a crime against children. Social workers recommended to family courts that parent’s care was unsatisfactory or negligent and were considered as experts by the judge and therefore more to be believed than the parents.. The family court judges nearly always “rubberstamped” the judge’s conclusions and authorized removal of the children concerned, the older ones to foster care and the babies to adoption. In effect, Punishment without crime.....
- 2) Councils were for the first time advised to take children” at risk” following “crystal ball predictions” of future harm by social workers and other “experts claiming that past behaviour was sufficient indication of future risk of physical or emotional harm to justify removal of the children.
- 3) Parents were no longer allowed to be represented by unqualified friends like myself applying for care orders to be discharged. Only family court lawyers (known as professional losers) could do that

and routinely they nearly always advised their clients not to fight social services. The result was that only 1 in 400 care orders was refused (judicial statistics).

- 4) Family Courts were declared “private” and therefore “SECRET” since parents whose children were taken lost the democratic right to protest publicly and were sent to prison if they revealed details of court proceedings. FREE SPEECH was denied.
- 5) With court approval children in care had their phones and lap tops confiscated to isolate them from family and friends. Both they and their parents were gagged during contact visits unable to discuss the court case, possibly coming home, or any abuse happening in care. If these rules were breached contact was stopped immediately. No language other than English was allowed during “contact” even when both children and parents were not native English speakers. These children are treated worse than convicted murderers in prison who can phone out and receive visitors who can chat with them on any subject they like in any language they choose!
- 6) Worst of all children are now regularly given by the courts for adoption by strangers even when their parents (most of whom have never committed any crime against children) are begging in vain to keep them. This applies especially to babies “snatched at birth” because their mothers have undesirable partners (or used to have them) or had childhood traumas or did not “engage with professionals (social workers). Once babies are adopted mothers nearly always lose all contact for life never knowing even if their children are alive or dead.

### Forced Adoption – Punishment without crime

I help two or three parents every day (around 1000 per year) by email or phone with free legal advice on how to get to court and what to say once there. My success rate is only approx 20% child recovery but that is better than that special breed of lawyers known as “professional losers” who do not try to win and have therefore a near zero recovery rate!

HOW TO PUT THINGS RIGHT? Well, I campaign quite simply for the old system (before 1989) to be restored where police and criminal courts deal with child cruelty and neglect. After all police will never arrest someone because they might commit a crime next year.

Criminal courts say “innocent unless proved guilty beyond reasonable doubt” unlike family courts who apply the civil proof of “more likely than not” branding parents as child abusers via guesswork. Imagine we need to send our police into these foster care and group homes, mental health facilities and apprehend and rescue our kids back from foster care and the child protection services. That is what we need to do! What an oxymoron!

After many reviews and reports about what needs to be fixed in our child care system we still have thousands of children suffering neglect in our foster homes, group homes and mental health facilities. Often these reviews and reports only include the input of the government and child care officials. Our children’s aid system in Ontario is going through such a review now in 2020. Who will be invited to speak at this review? If you really want to know what is wrong with the system wouldn’t you invite the parents of kids that have died. They have a lot to say about what happened. Or talk to the kids that have experienced neglect or hurt and their situation as they age out of foster care. Many of these children can explain eloquently what their experience has been and many want to go home. Invite the advocates of these families to speak and present their evidence.

Two mothers of children who have died in foster care asked to speak at such a review of the child care system in Alberta. Both were turned down. Why would you not want to know what went wrong and how it could be avoided in the future? Is it that the reviewers writing these reports don’t want to know the truth and fix the problems. Let’s have site visits to these facilities and homes.

We believe there should be independent reviews of the cases of ALL children currently in care, particularly those where there are no plans in place to return them to their families.

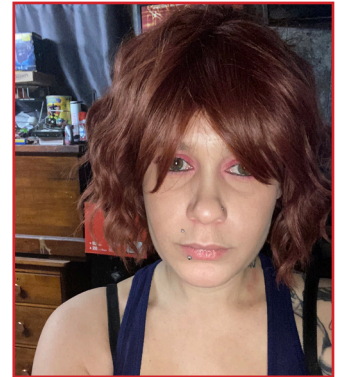

## Children Who Kill in Group Homes or Foster Care

It’s rare for a child to commit a serious crime and even rarer to commit murder. Murder is horrific and inconceivable but sadly in the child welfare system it can be linked to poor control and failure in group and foster homes., Following the court cases of the children it wasn’t difficult to learn what would push a child to such anger and kill.

Why Do kids Commit Murder? Perhaps because of the trauma they have endured. Life has become intolerable feelings are numbed. They are walking dead! Good care and love combined with qualified supervision are needed, something that is sorely lacking in group homes.

Do your own investigation and you will see many group homes are owned by employees of the government, or their relatives. Do child protection services hold life insurance policies on the children in care to collect if a child dies?

The Death of Lee Bonneau, 6, allegedly at the hands of a boy, 10, was avoidable, a report says. Lee Bonneau was found with severe head injuries in a wooded area on the Kahkewistahaw reserve in 2013. He had last been seen walking with an older boy outside a recreation complex while his foster mother was playing bingo – (CBC News – Posted: Apr 17, 2015) The jury considered the fact that the system “failed two families”.

Mathew Reid – three-year-old toddler was killed by Jennie Jane Ewing a 14-year-old the day after she arrived at a foster home in Welland, Ont.

David Roman was 13 in April 2017 when he was placed in a privately operated foster home in Barrie, Ont., where he was fatally stabbed in February 2019. Another teen in foster care at the home has been charged with first-degree murder. (Submitted by Elena Dvoskina) Battered, bloody and nearly naked, 15-year-old David Roman made a simple plea moments before he was stabbed to death in an Ontario foster home: “Please help me”. This is absolutely tragic; I am furious but not shocked.

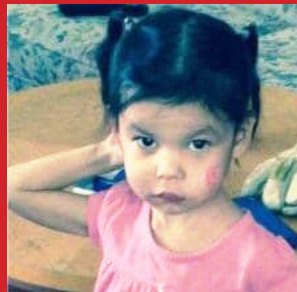

**Update from Serenity's mother** – PLEASE SHARE AS MUCH AS POSSIBLE... Well today marks a year since the charges that were laid and stayed on the people who were caring for my late daughter.

She died at 4 and half years old weighing just 18 pounds. She had severe hypothermia and during the preliminary hearing they stated she had broken toes and was severely malnourished and had no food in her stomach organs. She also had bruising to vagina and anal area. They say it was an accident and that she fell off a swing. The doctor told me and I have it on paper that it doesn't match up with a swing fall.

She had a pattern of bruising and lacerations all over her body as well, old and new bruises. They say there wasn't enough evidence and that they couldn't take my older kid's words into consideration who were also abused mentally and physically.

The charges were stayed for a year and today they're being thrown out. I am not sure how to deal with this. I just know that there should have been justice for her and her siblings .

Is it because she was indigenous? Was it because the social worker ignored my videos and pictures of them scared and complaining that they were being abused?

I'm sorry for those who read this and feel uncomfortable but it needs to be out there.

I feel like the RCMP lied to me continuously throughout the investigation; in fact I have a recording that proves it. What do I do?

# The Tragic and Preventable Death of Children in Government Care Driven to Suicide

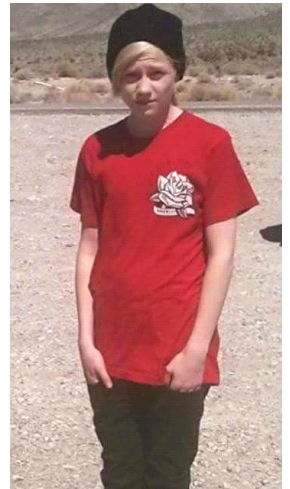
Suicide is often the result of wanting to bring a certain feeling to an end rather than a desire to die. The pain behind a suicide and the grief for the family is incomprehensible, a parent's worst nightmare.

In New-Brunswick, the Auditor General sounds alarms after finding kids as young as 4 in group homes. An article by Kim MacPherson fears 'disastrous consequences' as number of children in group homes grows – *CBC News*. Drugs, theft, alcohol and inappropriate relationships alleged at Children's Aid group home. By Alexandra Mazur Global News Posted May 30, 2019.

I don't have words. I just feel rage over the failure of some staff to protect these beautiful young people. Children under the authority of the Child, Youth and Family Services Act, live in residential settings including group homes, foster homes, hotels, motels and mental health facilities. It comes down to one question when parents ask for help and their kids enter these facilities; **WILL THEY COME BACK ALIVE!**

I have been to too many funerals. Children have suffered too many tragedies and traumas, more than they should be asked to bear. We are doing too little to make change and we must ask, **what have we done to shape their world this way. How are we responsible for the burden we are placing on these children today?**

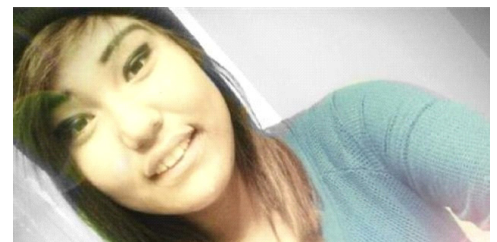
In B.C., Nick Lang's death was entirely preventable. Nick Lang was found dead in a closet on June 9, 2015 with a shoelace around his neck, six days after he was placed in the care of the Ministry of Children & Family Development (MCFD).



## Fatality inquiry hears teen complained of bullying in group home before suicide

Caseworkers convinced the family the best way to help Kyleigh Crier, a 15-year old girl with some emotional problems, was to give her over to the provincial protective care. The caseworkers then subjected Kyleigh to a dangerous and dysfunctional setting. Kyleigh Crier fatally hanged herself from a closet bar rod in an Edmonton group home. Before she died, she changed the banner on her Facebook page, posting a photo of a coffin with the words: "Now, everyone loves me."

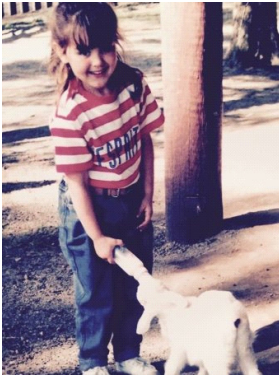

### Former foster child commits suicide after 55 placements

A 28-year old woman identified only as “Jolene” took her own life after having endured more than 55 foster care placements as a child. Jolene’s lawyer called Jolene’s life in and out of the clutches of the “child protection” agencies as one of the worst, one of the most shocking she’s ever seen.



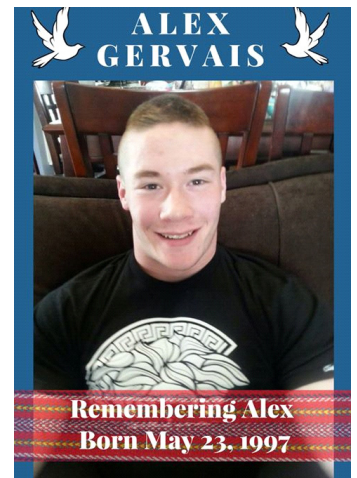
Jolene has been physically, emotionally, and sexually abused throughout her entire short, tragic life both at home and while in care. When she was 13 she was placed in an all-male youth refuge, where she was raped. She was admitted to hospital more than 100 times. Jolene’s lawyer, Neisha Shepherd, said her client wanted her story told so it might spare other foster children from the same plight.

*Protecting Canadian Children* is telling your story, Jolene. We care and we are so sorry! Remaining silent in the face of injustice is the same as supporting it.

Alex Gervais died alone after years of instability and neglect; says a child advocate report.

*Alex Gervais, 18, jumped to his death from a fourth-floor window of an Abbotsford hotel while in provincial care. – Staff Writer Feb. 6, 2017 2:00 p.m. NEWS – By Ashley Wadhwani, Vikki Hopes*

Gervais alleged that his caregiver was misappropriating the \$8,000 in funds that were meant to support the teenager, and leaving him alone and unsupported in a hotel. The caregiver only kept in touch by text messages. Alex spent 11 years being moved through 17 different living locations – including living in hotels – with 15 different caregivers. His caregiver at the time of his death was being paid \$8,000 a month to look after the teen in the hotel. This is not underfunding, this is incompetence of the system.



**Amy Owen 13** - From Poplar Hill First Nation, took her own life. On April 17, after she was taken out of her community near the Manitoba border and flown to live at a Prescott group home in eastern Ontario. Her father Jeffrey Owen, said; “She would secretly call us”. This is where it is so wrong, a child should never have to hide when they want to call their parents.

**Kanina Sue Turtle, 15**, Another Poplar Hill girl, Kanina was taken into care and she died Oct. 29, 2016.

**It is clear that we need to conduct unannounced inspections, in privately-run group homes and all the homes run by Children’s Services, Inc., and the Ministry of Children and Youth Services. Suicide is desperate, it’s tragic, and unbearable for the loved ones left behind.**

# Danger and Despair Inside Group Homes

It's every parent's worst nightmare

Failing Devon Freeman – SIX MONTHS! That's how long 16-year-old Devon Freeman was missing before his body was found in April 2018 hanging from a tree just 35 meters from the Hamilton treatment centre where he was living.

- On October 6, 2017, Devon when missing
- On October 28, 2017, grandma got a call
- No search was ever done
- No media attention until the end of November
- Their Excuses - He was labeled as runaways, obviously that they are somehow not worth the focus of the police or the media.
- So, why is it that so many kids are running away from those intuitions?



I'm tired, frustrated and I'm pissed. Why would they not report when he was found? How much do they want to disregard the human life of our youth?

Around the same time that Devon Freeman's body was discovered behind Lynwood, a coroner's panel was in the process of reviewing the cases of 12 other youth that died in foster care or group homes in Ontario. Kids who never made it out of the system alive like this beautiful soul Tyra Williams-Dorey. These deaths fit a pattern of negligence at Lynwood. It has brought attention to a system that seems to accept death and serious harm of our youth as "part of the business". This demand that this disparity to be addressed.

We don't have a shortage of disturbing stories under the child protection care.

# The Business of Child Sex Trafficking

One of the biggest businesses today, right up there with guns and drugs is child sex trafficking. The motive of traffickers is clear—money, an estimated \$150 billion in profits. — *International Labour Organization (ILO)*.

I faced the tragic reality in 2016, on Good Friday when I attended the “Stations of the Cross” and the “Annual Ecumenical Social Justice Walk”. I spoke to the crowd at the 5th Station and told them about the number of children dying in care. My friend, Barbara Lafleshe, talked about how studies show that 70 percent of Canada’s jail population and 70 per cent of its sex-trade workers passed through the foster care system.

When we got to the 7th station, I heard a Sister talking about human trafficking. I couldn’t believe my excitement. I thought she was the person I needed, to assist me with my cause. I went and introduced myself and asked if she would help us. I had a NO while she walked away from me. I was still naive enough to believe that these people would practice what they preach. I cried, believing the children have no hope for the future. Is hypocrisy in their DNA? Not preventing children from being sexually victimized is a real crisis and mis service to society!

My friend Sylva McLaughlin and I visited the office of the NDP, Children and Youth Services critic, Monique Taylor. Her job is to “promote consistently high quality, responsive service delivery to children and families receiving child protection services from Children’s Aid Societies (CASs) across the province.” I wanted to share my concerns about the number of children dying in care. I asked her if she would help *Protecting Canadian Children* regarding the level of care the children were receiving. We had a big fat NO! We were told that she was happy with the new policy working with “Child, Youth and Family Services”. They all work under the “Ministry of Children, Community and Social Services.” I think for me what hit me the most is the indifference when I mention the number of children dying in care.

Many ministries, children’s charities, government funded organizations and non-government funded organizations (NGOs) are actually facilitating child sex trafficking. These funded and privately run groups do not care about the welfare of children at all. If they did, they would do everything possible to keep children at home with their families, by supporting parents. Many child related charities are magnets for these predators and this is huge business. Children are being lured, groomed, manipulated, and coerced into slavery.

Trafficked children work 24 hours a day and 7 days a week and many are murdered. Many of these children are runaways or throwaways.

"Change is necessary, and the need is urgent," said the report, written by a panel of experts appointed by chief coroner Dirk Huyer last November to examine the spike of deaths between January 2014 and July 2017.

The Chief Coroner of Ontario tells us about the 1,065 children who died in 2018, many in the care of the children's aid society. How can that be?

It is disastrous for Canadian's souls to let Canada be broken beyond repair. Do you see the government's role to be destructive today?

*What if the people had the courage to stand up if something isn't right? What if the government was designed for good for all the people? What if we would not put up with anything else? What if?*



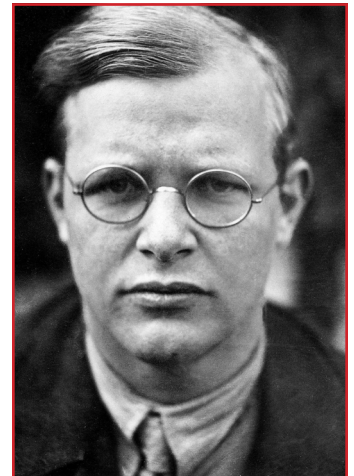

Will our inward power of resistance be strong enough, and our honesty with ourselves remorseless enough, for us to find our way back to ourselves?

Are we still of any use? In answer of this question, in my opinion, if you can no longer protect our families, friends and neighbors what good are we to anyone. What good is our government if they cannot do anything either?

## Harvesting Children's Organs



**Grand Chief 'horrified' Alberta quietly allows organ harvesting from children who die in provincial care** — *National News* | May 5, 2015 by Brandi Morin

The Grand Chief of Treaty 8 in Alberta says he was "horrified" to find out Alberta has a policy allowing for the harvesting of organs from children who die in the care of the province. The organ donation policy was first created in 2006, and applied to children in care under the status of a Permanent Guardianship Order (PGO). At the time, the ministry met with 18 First Nation agencies and 12 CEO's of Child and Family agencies to announce the policy and its implementation. Then, in 2014, the policy expanded to include children in care under a Temporary Guardianship Order (TGO).

I was horrified to learn about this policy. Are the public aware of this? Besides having children dying in care now they are harvesting the children's organs without the parents' consent. More money to be made.

## **Lack of funding — Really? Keep your wallets open and your mouths shut.**

Lack of funding is often stated as the excuse for so much, neglect, abuse, starvation and death for kids under child protection services. Funding is not the problem. That is just casting blame and shame on the Canadian tax payers to get more funding. When a child dies it is not because of lack of funding. It is because the employees are doing a miserable job when ignoring the daily neglect and abuse of children. More funding only means more children to apprehend! The fingers are all pointing to the ministers of the government and the employees of these agencies. Bring love to the children and you will see a lot less death and abuse! If this were parents doing this damage to children, they could go to prison for up to 25 years. Yet these workers have immunity under the law. WHY???

What are the links and the role of funding in child services and integrity in the public sector? Do you believe there is a need for more efficient and independent oversight and enforcement? This scourge persists because it is allowed to exist by the complicit authorities. It is too easy for child protective services to make unfounded accusations against vulnerable families and remove their children from their homes. These families have their charter rights and freedoms taken from them. Criminals under criminal law, have more rights and protections than these families.

Unnecessary dollars are spent in our court systems for judges, lawyers, social workers, foster care, psychologists, doctors, labs, police, and transportation. This is a money-making industry that has developed into many jobs and billions of dollars. In the end, the government does a terrible job of raising children. Many of these kids end up miserable, drug addicted, homeless, in jail, sex trafficked and dead. Canada would save millions of dollars and lives by leaving the families in tact and helping vulnerable families with groceries, clothing, educational supplies, clean, safe housing, clean water and good schools to really educate these children to prepare them for their own successful lives and good citizenship. Families can use parenting help, relationship building, work related skills and training. Give them a hand. Help them succeed. Don't take their kids away from them unless you can prove there is real need and then and only then take real good care of the children you do take into custody.

We recognize now that drug testing and forced vaccinations on foster children, child torture, murder, and organ harvesting is an 'accepted' practice at the highest levels of government, the NGOs, multinational corporations, as well as throughout academic institutions and civil society. This is heartbreaking to know the full extent of war that families and their children are fighting on the front lines--as they experience the harrowing reality of the modern battlefield of children services. This is the worst public crisis today and it is going to get worse.

**When public services are privatized it's always at the expense of the ordinary Canadian taxpayer. Do you think billions in funding buy votes and loyalty?**

Lack of funding is NO EXCUSE. Their failure to provide adequate care is called a "breach of duty and negligence." End their contracts. The tragic results of this state neglect have been illustrated throughout this magazine by a number of high-profile, tragic cases. What is so offensive after a tragedy happens, no charges are laid, other children living in the same home are not removed and the home remains open for business. Another tragedy waiting to happen!

## Supervised Visits for Families

Visits only take place in designated visitation centers where staff monitors every word that is said between parents and children with microphones overhead and cameras rolling. Children are brought from their residence to a visitation center, often one at a time. These visits can be highly emotional for families trying to fit so much into so little time.

If you dare to comment (like I did) in one visit, you are treated worse than a criminal. I will never forget the terrible screaming by the worker; leaving me with a jittery feeling that spread through my stomach. My head and heart began to spin. At that very moment I knew my family was in trouble. I didn't sleep for weeks reliving those moments in hell and trying to figure out, how to protect my family and how to deal with people who could behave so nastily with families. This awakening experience during my first visitation in the Catholic Children's Aid will never be forgotten. I also witnessed a scene that still haunts me today. A young mother was begging to have her baby back, and the worker was beyond cruel to her. The young trembling mother's words still ring in my ears: "You are working for the devil; "NO you are the devil."

Up to that point I had zero understanding of the malicious intimidations inflicted on families by the social workers. It was an emotional and torturous shock. Everyone has the right not to be subjected to any cruel and unusual treatment or punishment.

Convicted felons cannot be mistreated. They cannot be beaten, starved or killed. So why is it that children in care are being beaten, injured, starved, and killed? Why it is apparently okay to do to children what cannot be done to prisoners and inmates? Do you think I'm kidding about that? Not so! An inmate on death row has a priest and his family present on his last day. Not the children in care-- they die alone, without their family, and the child is returned in a GARBAGE BAG.

### Corona Virus, Foster Care and Family Services

The province of Ontario has been releasing more than 1,900 inmates over our Prime Minister's concerns for them, due to COVID-19. But Justin Trudeau was not concerned for the thousands of kids in foster care, group homes and mental health facilities. They cannot go home to their parents.

The awful policy was gone in an instant. When a child dies he believes those who are closest to these children should decide to speak or not – not the government. Children need protection in life not in death. We are not talking about daycare here, but the children’s life.” He was a real hero.

## How Secrecy Works

Let me illustrate more clearly how secrecy works. The public will never forget this shocking image of drowned Syrian boy Aylan Kurdi, 3 – face-down on a beach. Why? They saw the child, they saw his name. It happened!

Under the child protection services “secrecy is fundamental” to the success of these powerful organizations that ban the stories of children who die in their care. CPS controls the information and their public image. If the public saw the stories, the names, the faces of these children the public would not forget these children. The way it is now the stories are suppressed and people don’t know who, how many and how children are dying.

## The 1<sup>st</sup> Person to Have a Ban Lifted in Alberta

Velvet Martin was the first person in the province of Alberta to successfully have the Court lift the ban so that the truth could be legally shared. Since then, she teaches parents and their lawyers how to challenge the oppressive ban. Velvet herself was threatened with a lawsuit by individuals who attempted to have her criminally charged in order to prevent her from speaking the truth about what her daughter endured.

A Publication Ban is contrary to all that is humane. The existing lack of oversight and secrecy is a contradiction to all that life in Canada means to be. Consenting to such an agency’s interest is indeed monstrous.

# Their Wall of Secrecy is Coming to an End!

Is a publication ban being deliberately enforced to keep the people – you and me – from finally learning the truth?

Donald Langford, Executive Director with Metis Child and Family Services, insists children who die in care should be named. It is not difficult to define late Manmeet Singh Bhullar and Donald Langford as understanding the importance of caring for our most vulnerable.

Darleen MacDonald- Sssh... you're not suppose to know this.

In an article in CBC News under: **Leaks happen, the province needs to find a way to disclose kids' deaths in care, say privacy experts** – Aidan Geary – CBC News March 27, 2017.

Children's advocate Darlene MacDonald was 'livid' when that personal information was released saying public disclosure of sensitive details could increase risk to the families involved.

Let me make myself crystal clear, the biggest risk right now to the family is the system. When a child dies in care, we don't want to know the family history, we don't want to know their name, but what we want to know is the name of the child, why, how and who and most importantly we want to know why that child was removed. By doing so we will look at all people involved. Where it begins and where it ends. By doing so a caregiver and the workers will think twice before putting a child in danger.

In Alberta, Human Services Minister Dave Hancock and Katherine Jones, Executive Director of the Alberta Foster Parents Association, said media reports questioning foster care "should not be allowed."

Hancock himself seconded the opinion, saying "the public doesn't have the right to know everything." This says a lot about these two individuals.

They turn a blind eye and glance over the ugly to see what they want to see. Their job is about saving lives and helping families. This is disturbing now this man have been named a provincial court judge. Nothing will change, it appears they are part of a system as is.

Child death reports are strictly confidential because the death of a child would outrage Canadians. Keeping confidentiality only protects the system.

Here is a prime example: Sadly, Velvet Martin stood at far too many vigils for children murdered by their caregivers.

One little child and her family particularly remain close to Velvet because both of their girls were harmed in the same community. At the memorial for the child, a mother needed to beg camera-persons to stop recording because of the publication ban. Although another woman killed that mother's child, it was the mother herself who faced 6 months imprisonment or \$10K fine for simply paying tribute to her daughter by speaking her name to the media. It was at that moment that Velvet vowed to challenge this inhumane, unfair, harmful practice. Secrecy is ending.

## Disturbing Hiring Process

What we thought was true, wasn't true. We need to hold all the people who are involved with the child protection services personally liable for the harm done to children and their parents. There has been an outrageous disregard for human rights and human lives by two of the most trusted institutions, hospitals with doctors and the child protection services. The neglect goes beyond all standards of what is right and decent in their hiring practices.

1. Hospitals/Doctors: Talk about careers that make a difference in people's lives — doctors literally hold people's lives in their hands.
  2. The Child Protective Services: Talk about the biggest industry that can destroy the lives of children and parents in a short time even when there are no signs in the family of abuse or neglect.

### Mother Risk Testing Scandal – Profit at All Costs

For decades we the citizens have collected evidence, telling the government of the danger of this child welfare system. We are doing this because we are deeply concerned, and we believe in everyone following the law.

Dr. Gideon Koren represents one of the most disturbing examples of hiring incompetent people and then turning a blind eye to shoddy work practices of him and his employees. For years a system thrived where false drug tests were reported by this lab situated right in the Toronto Children's Hospital. Many parents lost guardianship of their own children because of being wrongfully accused of using drugs or alcohol when they were not guilty of such conduct. Was this not a breach of contract with the tax payers money, a breach of the trust of Canadian citizens and criminal negligence?



Motherisk Labs collected millions of tax payers dollars while accusing parents of conduct that was untrue and would result in the parents losing permanent custody of their own children. Who should be held accountable for this travesty of Canadian justice?

Read more about the Motherisk Drug Testing Laboratory's history and the scandal that engulfed it, reported by Rachel Mendleson of *The Toronto Star*, under the "Motherisk Hair Testing Scandal."

Tests, ranging from \$50 to \$150 brought in an average of \$1.3 million annually. Clients were primarily child services agencies. According to the *Toronto Star*, Ontario hired retired justice Susan Lang who investigated Motherisk's hair test lab procedures and protocols – *Bernard Weil, Toronto Star*. Lang reports that Media Time Limited's financial forecast showed income for 2004-05 of \$624,875 but between January 2007-2015 the lab's revenues topped \$11 million which came from children's aid organizations according to information released by the *Toronto Star*. Profits came first! The results of the tests came back as positive incorrectly. The lab lied and falsely reported parents as drug users.

Mr. and Mrs. Tax Payer how do you think a lab testing for hair samples went from a little over half a million dollars to \$11 million in 10 years working with children's protection services? That's your money at work and the lab was eventually closed down. Commissioner Susan Lang found Motherisk fell short of international forensic standards for use in child protection and criminal proceedings, and said the lab "frequently misinterpreted" the test results.

Dr. Michael Apkon, CEO at the Hospital for Sick Children in Toronto

In 2019 Dr. Apkon's Salary was – \$828,408.39. (The Most Outrageous CEO Salaries and Perks)



The fact that Koren was employed by child protective services to make decisions regarding the best interests of children is questionable at best. Read more about the apology from Sick Kids Hospital for the drug-test failings of its Motherisk lab as told by the Toronto Star reporter, Jacques Gallant.

Does it seem unfair that parents lost their children and did not get them back after false positive testing was exposed? Sick kids Hospital owed a “duty of care” to the public to provide competent medical services and employees who work according to high industry standards of an accredited lab.

To the readers: Would you agree that this was gross negligent of duty during his employment at the hospital?



Most doctors truly put patients’ care first, before profit but there are a few who inappropriately use their medical degrees for profit and those are the ones we need to get rid of right away. No second chance. No amount of money can replace a life. When they destroyed families for profit nothing can make that right!

Mary Ballantyne, Head of the Ontario Association for Children’s Aid Societies. (2019 Salary - \$239,935.05) Let’s focus on getting to know Mary Ballantyne who pointed the finger at Sick Children’s Hospital. As an employer what was her responsibility toward the public?

What was her hiring process? Pretty disturbing I say! When a government hires an agency to perform a duty for the public, they take on the responsibility good or bad for the results of their hiring practices.

Debra Edwards, by her offensive profanity reveals that the employees of CPS are missing an important part of being human. She is not suited for human needs. Her offensive behavior is no surprise to me. What makes her believe that she can be so destructive? This Cruel, Inhuman and Degrading Treatment is criminal and unacceptable. This is a huge Human rights issue. When Canada fails to show leadership to address the many aspects of the continued violation of the rights of families and the communities, it illustrates Canada’s failure to protect fundamental human rights guaranteed in international law. Canada’s blatant and continued violation of the rights of their own citizens under child services cannot be allowed to justify their failures. We have a massive crisis in leadership! **Alberta foster care supervisor charged with child pornography offences** *By The Canadian Press* - Daniel Quiring Stoesz, 62, was employed by the Government of Alberta, Ministry of Human Services and was a foster care supervisor in the Lac La Biche area.

**Hamilton, Ontario** – Child and youth worker charged with sexual touching of innocent children, such is the case of Kristopher Anderson, 36. The victim is a resident at one of the children agency's group homes where Kristopher Anderson, 36, was employed when the incidents took place. Kristopher invited the victim, who was under the age of 16, to engage in sexual activity on several occasions.

So many stories like this proves, in their hiring practices, these agencies often take persons who are exploiting children and choose their jobs with that prospect in mind to work with vulnerable children who are easy targets with out their parents around. They groom kids to be exploited sexually. This is a betrayal of the public trust the enabling laws bestow upon employees who will be put in positions of power over these children. Profit is the name of their game. They intentionally hire shady people, pay poor wages, and then assign these poor workers to care for our children.

These people can change the destiny of your family within a minute. They were giving a billion dollars under "the best interest of the child" where the public cannot see, and somehow no one seemed to see anything. Their job is to take children, Family has no chance, the corporations are the only winner. As for the public concern the Children's Aid is legit, so for those who run secretly the corporations what better way to run with employees without morality.

# The Family Court Justice? The secret state that steals our children

At the heart of the adoption/foster care system are the family courts, whose hearings are conducted behind closed doors in order to protect the identity of the children involved. Yet this secrecy threatens the decades-old tradition of Canada's legal system – the principle that people are innocent until proven guilty. From the moment a mother or father is first accused of being incapable as a parent – a decision nearly always made by a social worker or doctor – the system is pitted against them. Every year thousands of children are taken from their parents, largely on the say-so of “these professionals so called experts.”

There are no juries in family secret courts, only a lone judge, social workers and a few administration employees. The judge makes decisions based on the balance of probability. Relatives and friends are routinely forbidden to enter the court or give their testimony. It seems quite indefensible that there should be no publication by the media, and very often very limited access by the public, to what is going on in courts where judges are, day by day, making decisions to “take people's children away.”

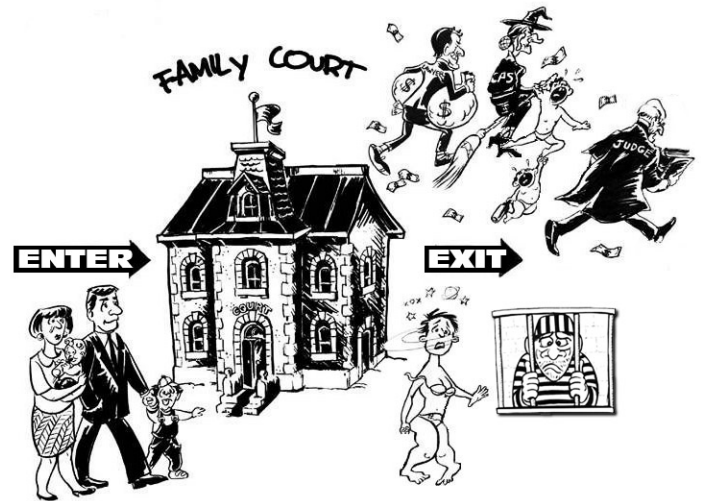
I have observed and attended many inquiries and family court on numerous occasions across Canada supporting parents. There was no shortage of seeing desperate parents who had their hearts ripped out by the family court. This gave me an emotional understanding of people caught up in circumstances beyond their control and the imbalance of power in these courts.

If you cannot afford a lawyer in Canada, there is a good chance you cannot access justice. There are no limits to legal costs for child protective services. They can take you to court as many times they want to. And they do! It cost them nothing out of pocket because it is billed to the tax-payers, millions of dollars while the families trying to defend themselves go bankrupt.

We need serious change in the family court. I have witnessed a high level of disturbing false evidence and there is no more common-sense in the court. The well-being of the child is grossly over-looked. That left me with a deep mark that we no longer have important qualities in judges like empathy and justice. For the affected families awaiting trial under the child protection services it is pure agony.

**We should consider removing family law matters from the adversarial courts altogether.** In the case of divorce the family's disputes could be moved into a specialized administrative system offering non-adversarial dispute resolution. This would leave no room for confusion and promote the well-being of children, reducing conflict and promoting the parents' ability to cooperate with each other. Surely, the public purse would be better spent with mediation by well-trained counselors.

Lawyers and paralegals with special training could really serve these families by encouraging the issues that families agree on and could work together to keep families as sane and productive as possible. This is big business for legal services but at what cost to the humans torn apart by an impersonal legal system that pillages them.

## The Family Court Justice? (continued)

In cases of children being apprehended without just cause and putting children at risk for profit under the privatized industry this should be handled in criminal court against the so-called professionals, experts who perpetuate a corrupt system. Let's prosecute the real law breakers. The privacy laws are being used to hide illegal, unethical and human rights abuses and the taxpayers are footing the bill.

Shouldn't the child protection services or any other party or groups observe the rules of international humanitarian law. Humanitarian law protects everyone, regardless of race, sex, religion, nationality, political opinion, culture or social status? The old adversarial, authoritarian, insensitive legal system our family courts have turned into do not benefit children. This should draw a firestorm of media criticism and attention.

While speaking with a family lawyer in New Brunswick she told us that judges appointed to family law in that province are given a GPS with their appointment because they don't even know where the family law court house is. All that to say that judges appointed to family court are sometimes not experienced in family law matters. Another lawyer told us off the record that we needed to go after the judges to fix the system. Some judges appointed to family court are not qualified to make decisions they need to make and therefore depend on the evidence and decisions of CFS to decide on a case for them. They are "YES" men to the CFS. How sad is that?

Lawyer John-Paul Boyd of Alberta, wrote a scholarly article Feb. 25, 2019 that, "Family justice in Canada is at a breaking point." Deep structural problems persist in how our justice system handles family disputes. We need to think seriously about a complete overhaul of the system. In spite of the reform efforts to date, public confidence is at an all-time low, the number of litigants without counsel continues to rise, and signs point to a worrisome trend of people choosing to opt out of the system altogether, abandoning the relief to which they may be entitled. It's time for some fresh thinking about what can be done. One solution may be a complete overhaul of the system, including allowing a wider range of professionals to take part. It's time for a critical examination of all potential alternatives, no matter how improbable they seem, without the assumption that business as usual is best merely because it's usual."

The family court system is adversarial right from the start, enriching lawyers. "Come on Canada; we can do better than that?"

Not all judges are bad. Here are two amazing judges that carried out their responsibilities with courage and integrity. In my personal case the judge was the Honourable Judge Genesee to decide if my grandson should come home. She carefully considered the evidence on both sides. Listening to the evidence presented to her she wasn't afraid to put the children's aid in their place. She returned my grandson to me!!!



# Equal Parenting for Children

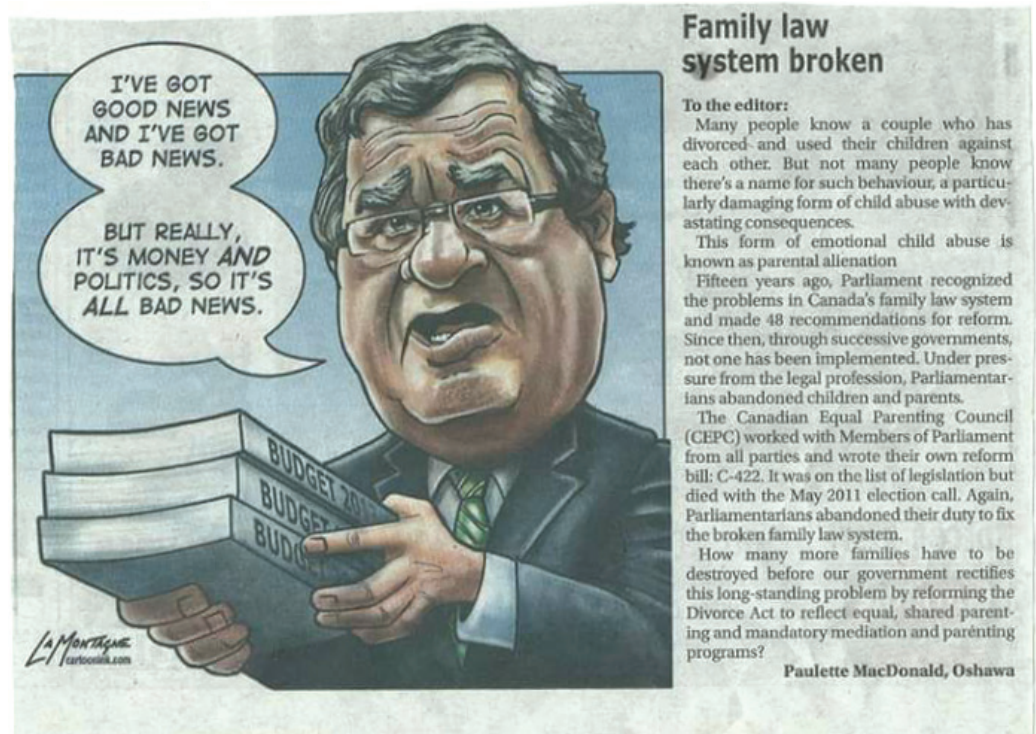

# The Simple Solution to Child Welfare Abuse and Neglect

Child Welfare work is some of the most difficult work that can be undertaken by the government. As every parent knows, raising children is HARD WORK. What may work for one child may not work for another. Children can come from the same parents but have completely different personalities. As a result, trying to raise children is an immensely difficult undertaking.

Child Welfare workers cannot adopt simplistic solutions such as to increase apprehensions or to decrease apprehensions. Because one general rule does not apply to all situations. The difficult reality is that each child needs the right decision. Apprehending when apprehension is not necessary damages the child. Not apprehending when apprehension is necessary can expose the child to further abuse and neglect.

The specific solution in each case will be different, therefore, you might think that it is impossible to find one solution to minimize neglect and abuse of children. However, I believe that there is one clear and simple solution that will drastically improve the condition for all children who become involved in the Child Welfare system.

Children need independent advocates and most importantly need independent lawyers to assist them. In Alberta, children can get lawyers through the government funded Legal Representation for Children and Youth Program (LRCY) through the Children's Advocate's Office. However, the problem with the LRCY is that it is not independent of the government. Almost 20 years ago, the Children's Advocate admitted so in its 2000-2001 Annual Report. Therefore, the LRCY will appoint lawyers that it has approved to represent children in Child Welfare proceedings, but the LRCY will never appoint a lawyer to help a child to sue Child Welfare. The obvious explanation is because the LRCY is funded by the government and cannot bite the hand that feeds it.

The result of this conflict of interest in the Child Welfare system is that when a child has been harmed by the Child Welfare system and needs accountability and compensation for the neglect, abuse and injuries that have been caused by Child Welfare, that child will not get accountability. One tragic example is the case of Steve. Steve was 4 years old when he was forced by Child Welfare to live in a foster home and was sexually abused for years. Steve did not know that his foster mother's live in common law husband was a convicted pedophile. When Steve finally reported the traumatic sexual and physical abuse when he was 12, Child Welfare did not tell Steve that the foster father was a convicted pedophile and they did not offer Steve an apology nor any compensation for the years of traumatic sexual abuse that he suffered. Child Welfare did not hire a lawyer for Steve. As a result, Child Welfare has never been held accountable for the gross incompetence of child welfare workers forcing Steve to live with a convicted pedophile.

The solution to prevent neglect is simple. Force Child Welfare to pay for lawyers for abused and neglected children to sue Child Welfare and hold them accountable for their gross incompetence. Once Child Welfare and its workers are held accountable for their mistakes, they will be more diligent in making right decisions that are in the best interests of children. The solution is very easy, unfortunately, governments don't want accountability they want to let people like Steve to suffer.

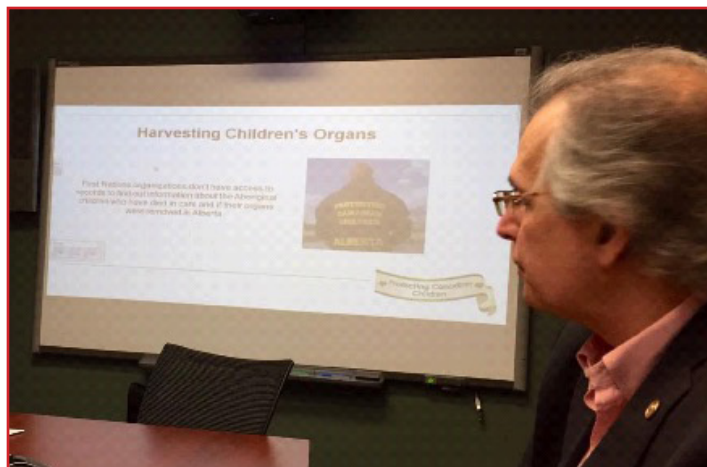

# You May not Know... But these Public Servants Do!

## HUMAN RIGHTS

Human Rights and Child Protection Services cannot be separated. Our efforts to inform them about the amount of children dying in care brought us to Ottawa on July 10, 2017. I thank Marie-Claude Landry (Chief Commissioner of the Canadian Human Rights Commission) for making this meeting possible. I had the pleasure of meeting her in Edmonton at the John Humphrey Awards ceremony in December of 2016. We met with Piero Narducci (Director General Human Rights) he was a very nice man but nothing came out of that meeting.



If the common language of the international community is indeed human rights, and genocide continues to happen, what does that say about human rights and the collective morality of our global community?



As Canada's human rights watchdog, the Commission is responsible for representing the public interest and holding the Government of Canada to account on matters related to human rights. So what do we learn from other nations when we see the danger of ignoring human rights violations. We should NEVER FORGET that human rights needs to be exercised in every community where people live, work, go to school, and worship. LET's REMEMBER, most violations of human rights result from policy choices. Who are they serving? Why do we have a Human Rights if they are not capable to do their job?

In 2019, we traveled to New-Brunswick and I visited the Human Rights Office in Fredericton, N.B., asking why while trying to nominate my friend Sylva McLaughlin for the "Human Rights Award" it was so difficult. I felt I was getting the run-around with great difficulties. I can't think of one occasion that I have nominated people, having such difficulty as this. It started to seem to me they simply did not want him to be nominated for a "Human Rights Award" perhaps because of the work he did with *Protecting Canadian Children*.



# In Search of Human Rights

I delivered a presentation at City Hall in Hamilton, Ontario on August 15, 2015. I wanted to be sure the City of Hamilton knew how many children were dying in care. I felt emotionally overwhelmed by mentioning the number of children dying in care. Every time I mentioned the number of children dying a little bit of me dies inside. Also, during the years I have approached; Amnesty International, UNICEF Canada, World Vision Canada, the Stephen Lewis Foundation and hundreds more. Hundreds of letters were written to public officials but for the most part I was treated dismissively and patronized.



Doing this magazine, I have had a front row seat to identify the failure of so many organizations that are unable, at best, or unwilling, at worst, to protect the human rights of children. Could it be that the political blocs manipulate and undermine the UN's human rights directives, and perhaps "funding" plays a major role in this? If you accept funding for your charity are you required to "yes" the government, talk nicey-nice about the status quo and not publish information that would put the government in a bad light?

Canada has a global reputation as the beacon of human rights for everyone. Is this a veneer at best? Is protecting and promoting human rights protections for children disregarded by all these organizations in Canada. Why is more not being done to protect children from atrocities? We can't be the only ones to see what is happening to children.

Let me say this as clear as possible: It would be a dangerous error of judgment to brush off their silence. Why? Think about it! Clearly, there is something very disturbing going on here as the results of their silence. The right to life must be respected. Children are fully human. They are fully deserving of human rights. How did it get to be this bad? We have a history of ineffective interventions, and we need the government to respond effectively. What I see in the past data of history is repeating itself.

Others make a lot of promises, but instead they produce disappointment with a promise to keep children safe. They want you to believe they are doing good but the result is all faked. Canada has given many charities a lot of money to do good, while our ability to protect our family is being erased. I do question the "loyalty" of the Prime Minister of Canada and the public servants toward Canadians and Canada. As a Canadian I am doing my duty, it is time they do theirs. Otherwise, Canada will be destroyed and we can say; bye, bye, to democracy, freedom and liberty. How will our children and grandchildren survive?

# The Personalities Behind the Betrayal, Greed and Deception

Where there's no visible accountability and crimes goes unpunished the world is unbalanced. Abusing tax dollars that we work so hard to earn, leaving very little to our own family's needs, is sticking it to each and every one of us. The follow-up effects are devastating to our entire society.

These examples below are supported by the Auditor General

1. The Grand Hotel on Jarvis St. in Toronto. (Craig Robertson/Toronto Sun) Toronto—The event hosted in Toronto at the Grand Hotel, was spearheaded by Central Toronto Youth Services (CTYS) and paid for by the Ontario's Ministry of Children and Youth Services. There were 125 officials who attended the event free of charge. Our jails are loaded with victims of the child welfare system. The Ministry of Children and Youth Services ought to devote the funds to quality education services, or access to mental health care or other services children need to heal instead of a weekend in a 5-star hotel. **Politicians are not cheap; you need to take care of them. They passed the law, they run the court, and in order for them to keep coming back and make things happen everything is on the house. 125 officials free!!**
2. Sudbury children's aid director Colette Prevost racked up a \$90K hotel bill December 7, 2015. She spent \$90,000 (over two years) on a Toronto hotel room including over \$10,000 in incidentals such as parking and telephone charges during her time as executive director of the Sudbury Children's aid. These "expenses" represent a significant increase to her already-liberal salary of \$100,000 and \$149,000 per year. Despite Prevost having repaid the "stolen" sum, it is shocking that such a breach of fiduciary duty could occur and that it would probably have gone unnoticed by the provincial government had it not been brought to their attention by a social worker at this office of the CAS. Equally shocking is that we have been unable to find that criminal charges were ever laid against Prevost.
3. Carolyn Buck Executive Director of the Toronto Children's Aid, drew not only a hefty salary but outrageously expensive perks, drew scathing criticism from provincial Auditor General Jim McCarter as part of his report on "widespread spending abuse" throughout this publicly-funded corporation. The AG's report noted that Buck's compensation included two SUVs worth more than \$50,000 and "numerous expenditures of hundreds of dollars at a time" charged to agency credit cards for restaurants that most taxpayers can't afford.

Buck "justified" gorging at the public trough with these expenses and another \$4,600 per year for gym and personal trainer expenses by saying that these lavish perks serve as "motivation to continue to do this very difficult work".

She also said "I'd like the public to understand that we pay very careful attention to how we spend our money here". If Buck was referring to lavish expenditures for the personal profit of CAS executives, she was exactly correct.

Meet Sylva McLaughlin, President of *Protecting Canadian Children* in Moncton, New Brunswick. As a very conscientious father Sylva inspired a book called—"Bon Papa" to encourage other fathers to cherish their children and make a lifetime of good family memories. The VON bought several copies in French and English to distribute freely to families.

Sylva has traveled to Alberta and Ontario to support the events of PCC and has been a strong educator for other families going thru the trauma of dealing with child protective services taking their children away from them. Sylva traveled to Alberta to support Jamie Sullivan when her child died after 6 days in care.

In Tracadie, NB, a mother of three fled the marital home with her children from an abusive violent husband and sought refuge in a special safe place for abused women. CPS took her children based on the fact that she did not have a real home for her children. They put the eldest with the social worker's own parents and gave the case of the violent husband to her sister

who is a lawyer creating two family financial gains from this mother's situation.

In Moncton, NB, a toddler was taken from his single mother after an invalid complaint about a suicidal tendency against her. I agree with taking the child away ASAP just in case for the safety of the child, but the following investigation with the medical experts in her life such as her family physician showed quite a healthy mother in all aspects of her life as well as in her grown up daughter's. Yet, the social worker kept denying supporting expertise and the court order to return the child to his mother. The mother is a remarkable example of tenacity and courage, because she had to act against fear she had facing continuous intimidation from the social worker. The mother and I worked hand in hand and got her son back in a record time. She is my reward for my 8 years of heart ripping work as a member of *Protecting Canadian Children*.

## When doing the right thing leads to arrest

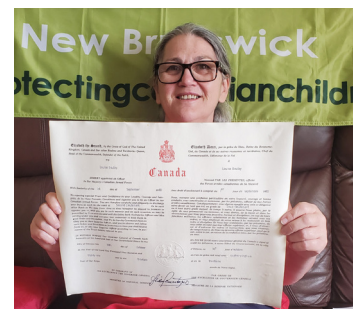

Other stories were submitted by either the parents, or family members that reached out to us through Protecting Canadian Children. My goal here is not to exploit what happened to these children. We want to bring awareness of what is happening and why this is happening under the child protective services.

Why are they failing so spectacularly despite numerous complaints for years? We are on to them. But what the public doesn't know and they need to know is we have reached a stage where we have a full bloom GLOBAL CRISIS under the Departments of Child and Family Services. We cannot allow children to continue to die in vain under these corporations and agencies that clearly don't have the protection of children at heart. We owe it to the children who died to protect the living. That is the only way to honour these children.

**ENGLAND:** Jonas Stadden, was cruelly snatched away after his mother made the mistake of asking the social services for help and advice. The four-year-old boy with Down Syndrome, died while in foster care after being removed by Somerset social workers from his devoted parents. (I am not sure what reason they used to take him.) Jonas died while under the care of temporary foster parents. What is a particularly disturbing feature of this story was that, four days before the boy's death, his father saw Jonas was so seriously ill that he pleaded for the foster parents to take his son to his doctor for urgent medical treatment. This never happened. The father of the boy had previously noticed burns and bruises on Jonas's body and informed the social services and the hospital. He was also savvy enough to photograph the injuries of his son. But his pleas fell on deaf ears. Months later, Jonas was pronounced dead. As usual the authorities went into full defensive mode. NOTHING could have been done to save this four-year-old boy who died in foster care, a coroner has ruled. Post mortem tests have shown that Jonas Stadden died of natural causes. Is that true?

**TEXAS:** Two-year-old Alexandria Hill was beaten to death by a foster mother recruited and trained by the US's largest for-profit foster care company, The Mentor Network. The company is owned by Civitas Solutions, Inc., which recorded \$1.4 billion in revenue last year and trades on the New York Stock Exchange. As BuzzFeed News reported in 2015, Taken Away From Parents Because they Smoked Pot at night after the kids went to bed. Texas deemed it was reasonable to remove her from a loving home because her father smoked pot while she was asleep.

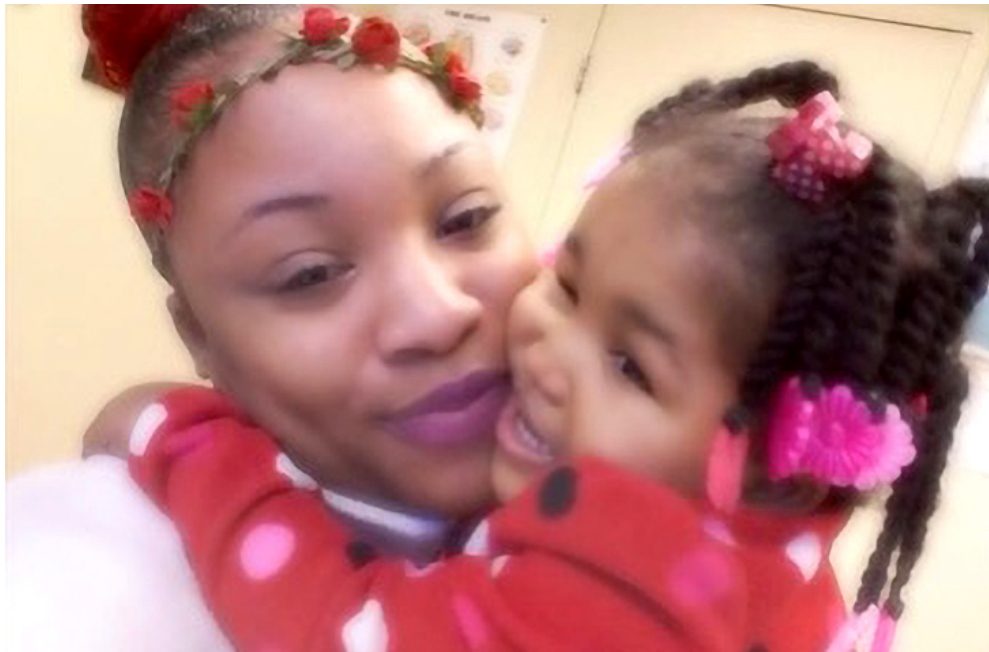


**In the UK:** Luke died while in the care of a 74-year-old woman who had three other foster children staying with her when she drifted into a deep sleep. Luke's father also had raised concerns about a burn and bruising when Luke was in respite care. But the coroner accepted they were accidental injuries normal to a two-year-old. Luke's father said the; "Child Safety" took my boy away and they gave him back to me dead." Mr Borusiewicz has put his energy into "Luke's Army," a group he formed for people battling child services.

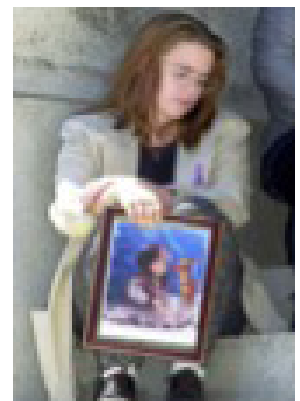

**LOUISVILLE, KENTUCKY:** THEY TOOK MY DAUGHTER AWAY FROM ME ALIVE AND GAVE HER BACK DEAD.... This is my story of my 6 year old special needs daughter Demiyah was taken to the pediatrician September 21, 2018 because she wasn't looking too well. The pediatrician examined Demiyah and said she was ok but I know my child I knew she wasn't ok. On September 22, 2018 I personally rushed Demiyah to the E.R. Tests were done on Demiyah and the results came back showing Demiyah was having heart failure. Child Protective Services we're called when Demiyah was being discharged from the hospital. I didn't understand why. When a caseworker arrived I was told they were called because they feel like I was neglecting Demiyah. Lord knows that was not the case. They seen my baby as a check!! These people sold my baby! They told me she was perfectly fine two days before she passed away! They lied! The state of Kentucky won't let me view my daughter's body. They are trying to hide what they have done to my baby. I knew something wasn't right that's why her visiting days were pushed back. Christy Lewis a mother with a broken heart!



**MAINE:** 5-year-old Logan Marr was found dead in the basement of her foster mother's home in Chelsea, Maine. The foster mother, Sally Schofield, a highly respected former caseworker for Maine's Department of Human Services (DHS), would later be tried and convicted of manslaughter after police determined that Logan had died from asphyxiation after being bound with duct tape and strapped into a high chair in the basement.

### **LONDON, ENGLAND:** Peter Connolly

Let down by everyone who should have cared: Report reveals appalling failures that led to Baby P's brutal death. By Jack Doyle and Arthur Martin for the Daily Mail Born in London, England and at this time, December 29, 2008 known only as "Baby P," a child who would die after more than 60 visits from the same social services who failed to protect Baby P. He was known to his family as "Smiley." Baby P was failed by police, social workers and lawyers. This toddler had 60 visits from agencies over 8 months. His 'horrific death' could have been prevented.



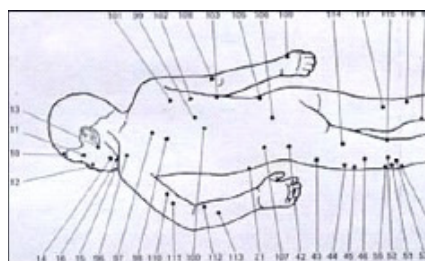
### **WILLIAM, MICHIGAN:** The case of seven-year-old Ricky Holland.

Beginning at age three, Ricky endured five years of terror at the hands of foster parents who were approved by MDHHS, first as foster care providers and then as adoptive parents. He was denied food, tied to his bed, led around on a leash, locked in a basement, beaten with a hammer and ultimately killed by his adoptive mother. Ricky was beaten to death by his adoptive mother when he was eight-years-old. His adoptive father threw Ricky's body in a pond. MDHHS failed this child by overlooking the severe and continued abuse that was right in front of them."



### **BRITAIN:** Victoria Climbié

A damning report has laid bare the "breathtaking" and "lamentable" failings that allowed eight-year-old Victoria Climbié to be tortured to death under the noses of police, social workers and doctors. Virtually no one involved in her case emerges with credit in Lord Laming's 400-page inquiry report, which blames a gross and inexcusable breakdown in the Victoria Climbié's life was short and tragic. Her disturbing death rocked the nation and the UK's child protection services.



A police diagram carried 128 injuries on Victoria Climbié's body.

### **FLORIDA:** Nubia Barahona

Nubia Barahona died after years of abuse by her adoptive parents, formerly her foster parents. She was abused and murdered. Her body was found wrapped in a plastic garbage bag in the bed of her adoptive father's pickup truck on the side of I-95 in West Palm Beach, Florida.

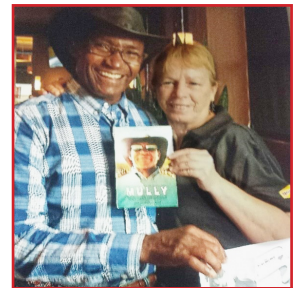

14. I would create a world where criminals go free and innocents go to jail.

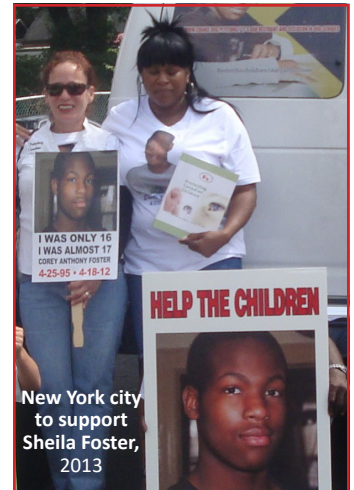
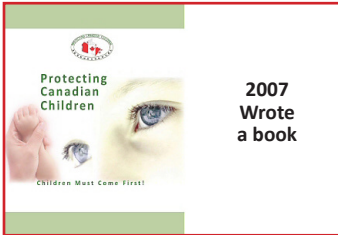
Everything I have written above is happening right now in front of your eyes.
